

Welcome to FindAResident™, a program of the Association of American Medical Colleges!

In order to use the FindAResident service, you, the subscriber, agree to the following terms and conditions of use (the "Terms"). If you do not agree with the Terms, do not use FindAResident!

FindAResident is a program of the Association of American Medical Colleges ("AAMC"). This agreement regarding the Terms of the FindAResident web site ("Site"), including the content ("Content") and services ("Services"), contained therein is made between you and the Association of American Medical Colleges ("AAMC").

Any violation of the Terms may result in the termination of the subscriber's FindAResident account. Account access will not be reinstated.

- **The Content provided on FindAResident is for the personal use of the subscriber only.**

Registration with FindAResident entitles a subscriber to access information posted by programs on available residency and fellowship positions, and allows applicants to notify programs of their interest in a program. FindAResident also allows applicants to post their resume for programs to review.

For a refund request to be considered, it must be made within three (3) days of purchasing a subscription. Please note: AAMC will not provide refunds to subscribers on the basis of search results for available positions.

Posting Rules

Your Résumé may not contain: (a) URLs or links to web sites, (b) copyrighted material (unless

you own the copyright or have the owner's permission to post the copyrighted material), (c) material that infringes on any other intellectual property rights, or on the privacy or publicity rights of others, (d) anything that is sexually explicit, obscene, libelous, defamatory, threatening, harassing, abusive, or hateful, (e) anything that is embarrassing or offensive to another person or entity, and/or (f) documents from any third party charging a fee or restricting complete access to all résumé information.

You may not use your Résumé to: (a) impersonate another person, living or dead, (b) post false, inaccurate or misleading information, (c) post advertisements or solicitations of business, (d) post chain letters or pyramid schemes, and/or (e) post opinions or notices, commercial or otherwise.

Conduct Rules:
