Minutes of AAMC Assembly Meeting

November 3, 1981

Washington Hilton Hotel, Washington, D. C.

Call to Order

Dr. Julius R. Krevans, AAMC Chairman, called the meeting to order at 8:15 a.m.

Quorum Call

The Chairman recognized the presence of a quorum.

Consideration of the Minutes

The minutes of the October 28, 1980, Assembly meeting were approved without change.

Report of the Chairman

Dr. Krevans reported to the Assembly on the activities of the Executive Council during the preceding year. He gave special attention to the Council's response to budgetary and legislative proposals, which resulted in the Association's setting as its priorities research and research training, student financial assistance, and support for the Medicaid and Medicare programs. He also mentioned several Association committees and their reports and discussed some of the policy issues on which the Council had acted during the past year.

Dr. Krevans extended a special thanks to the following individuals, whose terms on the Association's Administrative Boards had expired:

Report of the President

Dr. John A. D. Cooper provided the Assembly with the latest information about the fiscal year 1982 budget and appropriations process, including OMB action to defer expenditures of funds in excess of the Administration's September budget. Dr. Cooper anticipated that pressure to reduce funding for programs of interest to medical centers would not abate.

The Association has been notified that the Pew Memorial Trust would support its proposal for Regional Institutes on Geriatrics and Medical Education. The steering committee for this new AAMC initiative would be chaired by Joseph E. Johnson, III, M.D., Chairman of Medicine at the Bowman Gray School of Medicine.

Another new Association project, a study of the General Professional Education of the Physician, had been funded by the Kaiser Family Foundation. The Advisory Panel for this project will be chaired by Steven Muller, President of Johns Hopkins University. William Gerberding, President of the University of Washington, Seattle, will serve as vice chairman. The advisory committee will have broad representation from university and medical school faculties and the medical profession.

Dr. Cooper discussed the Association's activities with respect to the competition issue. Although there did not appear to be sufficient consensus in Congress for enactment of any of the existing competition proposals, Dr. Cooper predicted that medical centers and teaching hospitals would nevertheless be subject to mounting competitive forces and that there would be increased regulatory approaches to containing costs.

Report of the Council of Deans

Dr. Steven C. Beerling reported that the spring meeting of the Council of Deans had been devoted to "Crosscurrents of the Eighties." An additional feature of that program had been an orientation session for new deans. The Council had amended its rules and regulations to ex-

pand the size of its Administrative Board and to include as a member of the Board the Immediate Past Chairman of the Council. Dr. William Luginbuhl was named as new Chairman of the Council. Dr. Richard Janeway was named Chairman-Elect. New members of the Administrative Board were M. Roy Schwarz, D. Kay Clawson, Arnold L. Brown, and William B. Deal.

Report of the Council of Academic Societies

Dr. Daniel X. Freedman stated that the February interim meeting of the CAS had dealt with the proposed single route to licensure and external evaluation examinations. In March the Council had held an emergency meeting with representatives of the Reagan Administration to discuss budgetary matters. The CAS program at the Annual Meeting had included sessions on the appropriate college preparation for medical school, the role of basic scientists in clinical departments, the reinforcement of basic science education during clinical education, and the identification of basic science concepts for medical student learning.

Report of the Secretary-Treasurer

Mr. Stuart Marylander, in his report as Secretary-Treasurer of the Association, reviewed the activities of the Audit Committee and the Association's financial statement.

ACTION: On motion, seconded, and carried, the Assembly adopted the report of the Secretary-Treasurer.

Report of the Council of Teaching Hospitals

Mr. Marylander reported that the Council of Teaching Hospitals' principal project throughout the year had been its study of the distinctive characteristics and related costs of teaching hospitals. Although the study had been delayed by problems in obtaining all of the required data, it was anticipated the study would be ready for publication early in the next year.

Report of the Organization of Student Representatives

Mr. Grady Hughes reported that the OSR had increased its efforts to affect Congress on student financial assistance issues. The OSR had

also developed due process guidelines and had distributed an issue of the OSR Report on physician manpower. During the past year the OSR had also worked on a number of other projects, including a study of ethical issues at medical schools and a network for exchange of housing information. At the Annual Meeting the OSR had sponsored several discussion sessions and had passed a number of resolutions which would be transmitted to the Council of Deans. Ed Schwager was named Chairperson-Elect of the OSR.

Election of New Members

ACTION: On motion, seconded, and carried, the Assembly by unanimous ballot elected the following organizations, institutions, and individuals to the indicated classes of membership:

Amendments to the Association Bylaws

ACTION: *On motion, seconded, and carried, the Assembly by unanimous ballot amended the Association bylaws to read as follows:*

Article I, Section 2B:

Distinguished Service Members shall be persons who have been actively involved in the affairs of the Association and who have made major contributions to the Association and its programs.

Article I, Section 3E:

Distinguished Service Members shall be recommended to the Executive Committee by either the Council of Deans, the Council of Academic Societies, or the Council of Teaching Hospitals. The Executive Committee shall present Distinguished Service Member nominations to the Executive Council.

Article VI, Section 2:

The Executive Council shall consist of nine members elected by the Assembly and ex officio the Chairman, Chairman-Elect and Immediate Past Chairman of the Assembly and each of the three Councils created by these bylaws, the President of the Association, and the Chairperson and Chairperson-Elect of the Organization of Student Representatives, all of whom shall be voting members. Of the nine members of the Executive Council elected by the Assembly, one shall be a member of the Council of Academic Societies, one shall be a member of the Council of Teaching Hospitals, six shall be members of the Council of Deans, and one shall be a Distinguished Service Member. The elected members of the Executive Council shall be elected by the Assembly at its annual meeting, each to serve for three years or until the election and installation of a successor. Each shall be eligible for re-election for one additional term of three years. Each shall be elected by majority vote and may be removed by a

vote of two-thirds of the members of the Assembly present and voting.

Article VI, Section 7.

In the event of a vacancy on the Executive Council, either through resignation of an elected member or election of such a member to an ex officio seat on the Council, the remaining members of the Council may appoint a successor to complete the unexpired term. The Council is authorized at its own discretion to leave a vacancy unfilled until the next annual meeting of the Assembly. Members of the Executive Council are eligible for election to the Council for two full terms following completion of any partial term.

Report of the Resolutions Committee

There were no resolutions reported to the Resolutions Committee for timely consideration and referral to the Assembly.

Report of the Nominating Committee

Dr. John E. Jones, Chairman of the AAMC Nominating Committee, presented the report of that committee. The committee is charged by the bylaws with reporting to the Assembly one nominee for each officer and member of the Executive Council to be elected. The following slate of nominees was presented: AAMC Chairman-Elect: Steven C. Beering; Executive Council, COD representatives: John E. Chapman, M. Roy Schwarz; Executive Council, COTH representative: Mark S. Levitan; Executive Council, CAS representative: Frank C. Wilson, Jr.

ACTION: *On motion, seconded, and carried, the Assembly approved the report of the Nominating Committee and elected the individuals listed above to the offices indicated*

Installation of New Officers

Dr. Thomas K. Oliver, Jr. was installed as the AAMC's new Chairman at the plenary session immediately following the Assembly meeting.
