# College of Physicians AND Surgeons.

The Twelfth Annual Session of this College will begin on the first Wednesday in October, 1880, and will close on the first Tuesday in March, 1881.

Besides the usual didactic and clinical lectures—five daily, and work in the dissecting room from 8 to 10 P. M.—the course of study embraces practical work in analytical chemistry, demonstrations in histology and physiology, together with the use of the microscope, the stethoscope, ophthalmoscope, otoscope, laryngoscope, and all other available means of making physical diagnosis of disease.

**FEES.**—The entire cost for a full term, including material for dissecting room, but exclusive of graduation, is \$65. Graduation fee, \$20. Tickets for a *partial* course are: matriculation, \$5, and for each other ticket, \$10.

**REQUIREMENTS FOR GRADUATION.**—The candidate must produce evidence of good moral character, and must have attained the age of twenty-one years; he must have studied medicine three years or more, under a regular graduate, or licentiate and practitioner of medicine in good standing, using the word “regular” in the sense commonly understood in the medical profession. He must have attended two full terms at least, at some “affiliated” college or colleges, the last of which must have been at this college. He must also have passed a satisfactory examination in all of the branches of medicine taught, and must have paid all dues, including the graduation fee.

Our regular Annual Announcement will be issued about the first of June, and any physician or medical student not receiving one will be supplied on application to the Dean, to whom all communications should be addressed.

## ANNOUNCEMENT.

---

In issuing their twelfth annual announcement, the Faculty of the Kansas City College of Physicians and Surgeons take pleasure in bearing record to the growing prosperity of the school, as evinced by the increase in the size of its classes and the assurances of confidence and support which are being continually received from members of the profession in this and adjoining States.

The Faculty thus feel assured that their quiet determination to build up a strictly reputable school upon the solid basis of true merit is being appreciated by those whose good opinion they most desire, and they would renew to the profession their assurance that in the management of their own affairs, as well as in the counsels of the American Medical College Association, they will ever continue to advocate such measures as shall tend to elevate the standard of medical teaching. In this connection, they would record with pleasure the action of the American Medical College Association at their last meeting, whereby it is ordered that "at and after the session of 1882 to 1883, *attendance on THREE yearly sessions* shall be required previous to graduation."

A grave loss was sustained in the teaching force of this College through the death, on September 13, 1879, of Professor A. B. Taylor, who for many years had so ably and acceptably filled the chair of Surgery. Uniting rare practical knowledge with more than ordinary original gifts, he had given a character to the teachings of his chair which will not soon be forgotten by those who were his pupils, while his loss will long be mourned by his former associates.

The vacancy in the chair of Surgery was filled last year as follows: Professor Halley lectured on the Principles of Surgery,

Professor Griffith on Operative Surgery, and Dr. F. M. Johnson on Fractures and Dislocations. The first two of these gentlemen having, at so short notice, assumed this extra duty in addition to filling their own chairs, are entitled to special credit and to the thanks of their colleagues.

For the coming session, the chair of Surgery will be filled by Dr. W. S. Tremaine, Surgeon U. S. A., for some years past stationed at Fort Dodge, Kansas. Dr. Tremaine is well known to the medical profession in the West as a gentleman of high culture, thoroughly informed in the literature of his science, and as a practical surgeon. He is about to settle in Kansas City, and the Faculty deem themselves fortunate in being able thus satisfactorily to fill this chair.

Dr. F. M. Johnson has been appointed to the chair of Fractures and Dislocations and Clinical Surgery.

Arrangements are being made for special instruction in Microscopy and Pathological Anatomy.

It will thus be apparent that by an increase in its teaching force, as well as in the branches taught, this College will be able to offer to the student better facilities than ever before for a thorough course of medical instruction.

#### SESSION OF 1880—1881.

---

The Twelfth Session of the Kansas City College of Physicians and Surgeons will begin on the first Wednesday in October, 1880, and will close on the first Tuesday in March, 1881.

The course will comprise a full series of Didactic and Clinical Lectures on the usual branches of study, Practical Anatomy, and daily examinations on the subjects taught.

#### CLINICAL INSTRUCTION.

Clinical instruction in Practical Medicine, Surgery, Midwifery and Diseases of Women will be given, from time to time, at the Hospitals and Lecture Room.

The City Hospital, to which students are admitted free of

charge, furnishes abundant opportunities for the study of Clinical Medicine and Surgery.

St. Joseph's Hospital, under the care of the Sisters of St. Joseph, through the courtesy of its managers, is also open to the visits of the class for clinical observation, under the guidance of members of the college Faculty.

Kansas City being one of the great railroad centers of the country, with a large population engaged in manufacturing interests and mechanical pursuits involving liability to accident, these hospitals afford ample means of witnessing every kind of disease and injury, all of the common and many of the rarer surgical operations.

The College clinics are rapidly growing in number and value, being made up mainly of patients from abroad who visit the city seeking advice and treatment for surgical and other diseases.

Advanced students will be afforded facilities for studying Midwifery at the bedside.

*Examination, advice and surgical operations in the presence of the class are gratuitous to those who are not able to pay for the same.*

#### PRACTICAL ANATOMY.

The law of this State provides that the bodies of all persons dying in Charity Hospitals or Poor Houses, and unclaimed by friends, may be turned over to medical colleges for purposes of dissection, thus amply providing the Faculty with anatomical material, which is furnished students without extra charge. Demonstrations and examinations in the Dissecting Room every evening. The opportunities given for the study of practical anatomy cannot be surpassed.

After the first of January and till the end of the session, those intending to graduate will be organized into a class for special instruction in surgical anatomy and practical surgical manipulations on the cadaver.

Advanced students will be given an opportunity to study the higher branches of anatomy and physiology in the Physiological Laboratory, under the direction of the professor of anatomy. This course is only established with the view of giving an opportunity to advanced students to prosecute their studies without extra charge, and in anticipation at an early day of incorporating such instruction in the regular course.

**CHEMISTRY.**

The course of Chemistry will consist of Lectures on Chemical Physics, Inorganic and Organic Chemistry, fully illustrated by practical experiments. Connected with this department, there has been established a complete Chemical Laboratory, in which students can take a full course in practical chemistry without additional charges except actual cost of chemicals used.

**OPHTHALMOLOGY AND OTOTOLOGY.**

This department will remain under the admirable management of Professor Fryer, U. S. A. Post Surgeon at Fort Leavenworth, who has for many years past made special study of the diseases of the eye and ear.

His lectures, which are held during the entire term, are very fully illustrated with drawings, models, etc., and his Eye Clinics have been full and exceedingly interesting.

**COLLEGE BUILDING.**

The college building is situated at the junction of Main and Delaware streets. The rooms are ample and well furnished with every necessary convenience. The main lecture room is being enlarged and remodeled in such manner as to double its seating capacity and greatly improve its qualities as an auditorium.

**HOLDEN PRIZE FUND.**

This fund is the liberal gift of one of our fellow-citizens, Howard M. Holden, made with the stipulation that the annual interest thereof (\$100) shall constitute a cash prize, to be awarded at each Annual Commencement to that student who shall, upon his final examination, show the greatest degree of proficiency in his studies.

**FACULTY PRIZE.**

The Faculty offer a second prize, of \$25, to the student passing the second best examination.

**FEES.**

The aggregate cost of a full course of study for one term is \$65, as follows:

Matriculation fee, (to be paid but once,) \$5.

Fee for the Professors' tickets, \$50.

Ticket of Demonstrator of Anatomy, \$10.

Tickets for a *partial* course are: Matriculation, \$5; and for each other ticket, \$10.

The Graduation fee is \$20.

Tickets must be taken out and paid for at the beginning of the term, and the taking of promissory notes from students is strictly forbidden by the By-Laws of the College.

#### REQUIREMENTS FOR GRADUATION.

The candidate must produce satisfactory evidence of good moral character and must have attained the age of twenty-one years.

He must file a satisfactory certificate of having studied medicine for at least three years under a *regular* graduate or licentiate and practitioner of medicine, in good standing, using the word "regular" in the sense commonly understood in the medical profession.

He must file the proper official evidence that, during the above-mentioned three years, he has matriculated at some affiliated college or colleges for two regular sessions, and in the course of the same has attended two full courses of instruction on the following branches of medicine, to wit: Anatomy, Physiology, Chemistry, Materia Medica and Therapeutics, Obstetrics, Surgery, Practice of Medicine and Pathology. The latter of these two courses must have been attended at this College.

He must also have passed a personal examination before the Faculty on all of the branches of medicine above-mentioned, and must have paid in full all college dues, including the graduation fee.

ARTICLES OF CONFEDERATION  
OF THE  
AMERICAN  
Medical College Association,

(TO BE SUBSCRIBED AND CONFORMED TO BY ALL COLLEGES  
OF THE ASSOCIATION.)

---

ARTICLE I.—*Of the Faculty.*

The medical members of the Faculty must be *regular* graduates or licentiates and practitioners of medicine, in good standing, using the word "regular" in the sense commonly understood in the medical profession.

ARTICLE II.—*Tuition.*

SEC. 1. The scheme of tuition shall provide for a yearly systematic course of instruction covering the general topics of Anatomy, including dissections, Physiology, Chemistry, Materia Medica and Therapeutics, Obstetrics, Surgery, Pathology and Practice of Medicine. The collegiate session, wherein the course is given, shall be understood as the "regular" session.

SEC. 2. Said regular session shall not be less than twenty weeks in duration. This section to go in force at and after the session of 1879-80.

SEC. 3. Not more than one regular session, counting the regular session as one of the two courses of instruction required for graduation, shall be held in the same year.

ARTICLE III.—*Requirements for Graduation.*

No person, whether a graduate in medicine or not, shall be given a

diploma of "Doctor of Medicine" who shall not have fulfilled the following requirements, *except* as hereinafter provided for in Article IV.

1. He must produce satisfactory evidence of good moral character, and of having attained the age of twenty-one years.

2. He must file a satisfactory certificate of having studied medicine for at least three years under a *regular* graduate or licentiate and practitioner of medicine, in good standing, using the word "regular" in the sense commonly understood in the medical profession. No candidate shall be eligible for final examination for graduation unless his term of three years' study shall have been completed, or shall expire at a date not later than three months after the final examination. This clause to take effect at and after the session of 1879-80.

3. He must file the proper official evidence that, during the above-mentioned three years, he has matriculated at some affiliated college, or colleges, for two regular sessions, and in the course of the same (except as provided in 4) has attended two full courses of instruction on the seven topics mentioned in Article II. But the *latter*, at least, of the two full courses must have been attended at the college issuing the diploma. No two consecutive courses of instruction shall be held as satisfying the above requirements unless the time between the beginning of the first course and the end of the second is greater than fifteen months.

4. In case a college shall adopt a systematic graduated scheme of tuition, attendance on the whole of the same shall be equivalent to the requirements mentioned in 3; *provided* such scheme includes instruction in the seven topics mentioned in Article II, and requires attendance at at least two yearly regular collegiate sessions of not less than twenty weeks duration each.

5. The candidate must have passed a personal examination before the Faculty on all seven of the branches of medicine mentioned in Article II.

6. He must have paid in full all college dues, including the graduation fee.

#### ARTICLE IV.—*Of Honorary Degrees.*

An honorary degree of "Doctor of Medicine" may be granted in numbers not exceeding one yearly, to distinguished physicians or scientific men of over forty years of age. But in such case the diploma shall bear across its face the word "honorary" in conspicuous characters, and the same word shall always be appended to the name of the recipient in all lists of graduates.

#### ARTICLE V.—*Of Fees.*

SEC. 1. All fees shall be paid in lawful money, and no promissory notes or promises to pay shall be accepted in lieu of cash for payment of fees.

SEC. 2. No ticket or other certificate of attendance upon college exercises, shall be issued to any student until the dues for the same shall have been fully paid.

SEC. 3. The established fees for the exercises of the regular session, except the matriculation fee, graduation fee, fee for dissections, may be reduced not more than one-half to graduates of other affiliated colleges of

less than three years' standing, and to undergraduates of the same who have already attended two full courses of the instruction of the regular session.

SEC. 4. The same fees may be remitted altogether to a college's own alumni, to graduates of other affiliated colleges of three years' standing—the three years dating from the time of graduation and ending at the close of the regular session for which the tickets are given—to undergraduates who have already attended two full courses of the instructions of the regular session, the latter of which, at least, shall have been in the college making the remission, and to theological students, when not candidates for a diploma.

SEC. 5. The same fees may be reduced or remitted to deserving indigent students, to a number not exceeding five per cent. of the number of matriculates at the previous regular session of the college.

SEC. 6. Under no other circumstances whatever, other than the above, shall the Faculties, or any members of the same, grant, *upon their own authority*, any remissions or reductions of established fees. And it is distinctly understood and agreed that the faculties will discountenance and oppose the authorizing by governing boards, of the admission of individual students upon other than the regularly established charges for their grade.

SEC. 7. Remission or reduction of fees for other exercises than those of the regular session, return to a student of any moneys after payment of fees, or an appropriation of funds of the college for payment of any student's fees, or part thereof, shall be deemed violation of the provisions of this article in regard to remission or reduction of fees.

#### ARTICLE VI.—*Of Recognition of other Colleges.*

No college shall admit to the privileges accorded in Article III and IV the students or graduates of any college which, during any period of the student's or graduate's pupilage, shall have been excluded from the list of affiliated colleges recognized by the Association.

#### ARTICLE VII.—*Amendments.*

Amendments to these Articles shall be proposed and adopted in the manner prescribed for amendments to the constitution.
