

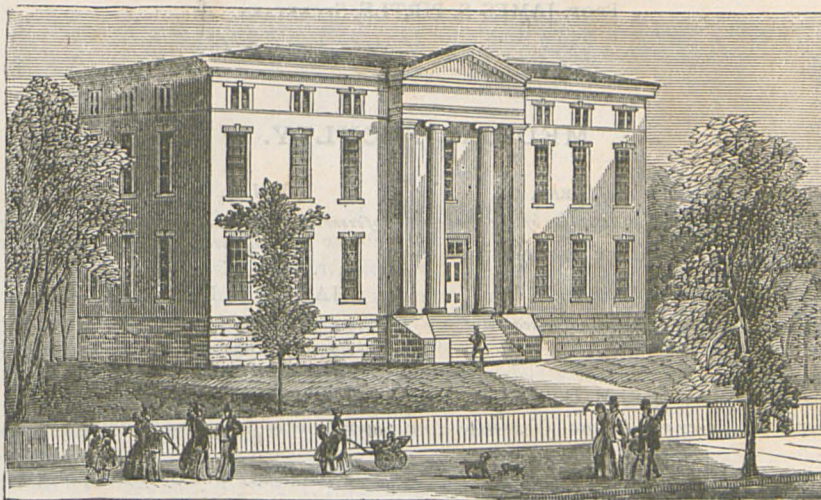

## ANNUAL ANNOUNCEMENT.

---

The Forty-third Annual Session of this Department was successful to a degree extremely gratifying to its Trustees, Faculty, and friends.

The city of Louisville, in 1837, donated a square of ground containing four acres, and appropriated fifty thousand dollars to erect and equip an edifice suited to the requirements of a first-class Medical College. This property, now lying in the heart of the city, has advanced largely in value, and its profits are devoted to the University. The Lecture-rooms, Cabinets, Library, Laboratories, and Dissecting-rooms are furnished with every thing necessary for convenience and instruction, while its Museum, already one of the finest in America, is being constantly added to from various sources. In apparatus, models, drawings, preparations, and specimens for illustration by the various chairs, the institution possesses every requisite for thorough medical teaching; and, in view of its perfect equipment, the Board feel safe in assuring its friends that it never before presented stronger claims to the confidence and support of the medical profession.

### CLINICAL MEDICINE AND SURGERY.

It is the determination alike of the Faculty and Trustees to secure to students that kind of information which will be most useful to them in active professional life; and it will be seen that no effort has been spared to make the University essentially a *practical* and *demonstrative* school.

THE UNIVERSITY DISPENSARY, which is the property of the Faculty, affords great facilities to students. The building is upon the University grounds, and is open to patients and students throughout the year. It is the oldest institution of the kind in Louisville. It has obtained the confidence of the sick poor of the city, and its clinics are daily crowded with patients illustrating all varieties of disease. The advantages accruing to the University students from this source are among the chief attractions of the institution, giving them opportunities for attending cases and witnessing diseases in every phase. The DISPENSARY furnishes material for DAILY COLLEGE CLINICS from the following chairs: Clinical Medicine, Clinical Surgery, Diseases of Women, Diseases of Children, Diseases of the Heart and Lungs, Diseases of the Eye and Ear, Diseases of the Skin, and Diseases of the Nervous System.

In addition to the daily College Clinics mentioned, two Medical and two Surgical Clinics will be held weekly in the commodious amphitheater of the CITY HOSPITAL.

The Professors of Clinical Medicine and Clinical Surgery will lecture in the Hospital during the session. In addition to the above the abundant clinical material of SS. MARY AND ELIZABETH HOSPITAL is at the command of the University Faculty.

### FREQUENT EXAMINATIONS.

Universal experience has demonstrated the paramount importance of this mode of instruction as supplemental to lectures, and the Faculty has made a special provision for it. The wisdom of this action has been abundantly shown. The Faculty therefore devote additional hours for the purpose of a general "quiz," to be conducted by themselves.

## PRACTICAL ANATOMY.

The city of Louisville offers abundant opportunity for the study of practical Anatomy. Material is plentiful and will be furnished at a moderate price. The Dissecting-room of the University is admirably adapted for its purposes, being extraordinarily large, well ventilated and lighted, and furnished with all the conveniences for cleanliness and health. It is open daily, Sundays and Saturdays excepted, from eight to half past ten o'clock, P. M. The demonstrator and his assistants give personal superintendence at the tables, and render instruction by *separate demonstrations and frequent examinations.*

In view of the importance of this branch of medical instruction, the authorities of the University urge all students to take the ticket in Practical Anatomy. The wisdom of this course will be conceded when it is considered that this foundation of all medical science must almost necessarily be obtained in organized dissecting-rooms, and that the custom of requiring but one course of dissection is a tradition of the past which arose simply from the difficulty in obtaining material.

## FORTY-FOURTH ANNUAL SESSION.

The Forty-fourth Regular Annual Session will commence on October 1, 1880, and will continue until March 1, 1881. Previous to this there will be a preliminary course of lectures free to all students, opening Monday, September 20th, and lasting until the beginning of the regular term. This course will consist of a series of lectures on the following subjects:

## FEES.

The fee for admission to the entire Course of Lectures is SEVENTY-FIVE DOLLARS, payable, as are all the fees, *invariably in advance.* The Matriculation Ticket is FIVE DOLLARS, and gives the student the use of the extensive Library of the institution during the winter. The Graduation Fee is THIRTY DOLLARS. The Fee for admission to the Dissecting-rooms and for instruction by the Demonstrator of Anatomy is TEN DOLLARS. The Fee for the Hospital Ticket (required by the city) is FIVE DOLLARS.

## SPECIAL AND OPTIONAL MANIPULATIVE COURSES.

The continued success of the practical exercises in Laboratories especially fitted with Beck's microscopes, sets of chemical reagents, manikins, ophthalmoscopes, laryngoscopes, etc. etc. has confirmed the wisdom of the Faculty in instituting these courses.

Every facility and all needful apparatus are furnished to make these teachings of permanent value to the student.

The fee for all these departments is FIFTEEN DOLLARS. The fee for a single department is FIVE DOLLARS.

It is especially recommended that first-course students should take Medical Chemistry and Microscopy, for which a fee of FIVE DOLLARS will be charged; and second-course students the three other courses, for which a fee of TEN DOLLARS will be charged.

*These special courses are optional.*

It is urged upon all who seek to train their senses to the requisite degree of skill to make good diagnosticians and operators that at least one course of each of the manipulative branches be taken before applying for the degree.

### REQUISITES FOR GRADUATION.

1. The candidate for the degree of Doctor of Medicine must have attained the age of twenty-one years, and sustained a good moral character.
2. He must have studied medicine not less than three years, "or his three years' study shall expire at a date not later than three months after the close of the final examination."—*Articles of Confederation American Medical College Association.*
3. He must have attended two complete Courses of Lectures, the last of which shall have been in this institution, have taken the ticket of the Demonstrator of Anatomy one session, and have attended one Course of Clinical Instruction in the Louisville Marine Hospital, or some other institution approved by the Faculty.
4. Students who have read the requisite time and attended a full course of lectures in a recognized medical school are admitted to examination in this school after attendance upon one complete course.

The candidate, at the time of applying to the Dean for admission, must exhibit his tickets as proof of compliance with the above rules. He must have paid in full all college dues. The graduation fee must be paid to the Dean by the 1st day of February, and will be returned in the event of the candidate's withdrawal or rejection. The presentation of a Thesis is not required.\*

The examinations for the degree are on all the branches taught in this College.

### HONORS AND PRIZES.

As the experience of this College has been that the system of conferring prizes for excellence in special branches tends to the concentration of the student's mind upon a single department to the neglect of others equally important, it has therefore been determined that the honors and prizes of the University shall be given for general excellence only.

To each of the ten men standing highest in the final examination a certificate of honor will be awarded. To the student standing at the head of this list the "Yandell"† gold medal for first honor will be given; to the one standing next a gold medal for second honor, and to the one standing third a gold medal for third honor will be awarded.

### PRIZES FOR FIRST-COURSE STUDENTS.

In order to stimulate students who are not of the graduating class to study, especially in the fundamental branches of Medicine, a special examination will be held near the end of the Term on the subjects of Anatomy, Physiology, Materia Medica, and Chemistry, and to each of the three showing the greatest proficiency prizes will be awarded as follows:

To one, a case of Instruments, by Simon N. Jones, of "The Pharmacy," Louisville, Ky.

To one, a case of Instruments, by Arthur Peter & Co., wholesale druggists, of Louisville, Ky.

To one, a copy of Gross's or Erichsen's System of Surgery, by John P. Morton & Co., book-sellers and publishers, of Louisville, Ky.

This examination of first-course students is voluntary.

All honors and prizes will be announced and awarded by the President at the Annual Commencement.

\*In compliance with the recommendation of the Convention of Medical Colleges, the option of three Courses of Lectures is offered to students according to the following plan: "Students who have attended two full Courses of Lectures on Anatomy, Physiology, Materia Medica, and Chemistry, may be examined upon any of these subjects at the end of their second course. During their third course such students may devote themselves to the Lectures upon the Theory and Practice of Medicine, Surgery, and Obstetrics, and Diseases of Women and Children, upon which subjects only they shall be examined at the final examination for the degree of M. D.—their standing, however, to be determined by the results of both examinations.

†This prize is named in honor of the late Prof. L. P. Yandell, who was the last of the original Faculty of this institution.

## ARTICLES OF CONFEDERATION.

(To be subscribed and conformed to by all the Colleges of the Association.)

## ARTICLE I. Of the Faculty.

The medical members of the Faculty must be *regular* graduates or licentiates and practitioners of medicine, in good standing, using the word "regular" in the sense commonly understood in the medical profession. The majority of the members of one Faculty shall not constitute the majority of the members of another Faculty, unless the sessions of the two schools are held simultaneously.

## ARTICLE II. Of Tuition.

SEC. 1. The scheme of tuition shall provide for a yearly systematic course of instruction, covering the general topics of Anatomy, including Dissections, Physiology, Chemistry, Materia Medica, and Therapeutics, Obstetrics, Surgery, Pathology, and Practice of Medicine. The collegiate session wherein this course is given shall be understood as the "regular" session.

SEC. 2. Said regular session shall not be less than twenty weeks in duration. This section to go in force at and after the session of 1879-80.

SEC. 3. Not more than one regular session, counting the regular session as one of the two courses of instruction required for graduation, shall be held in the same year.

## ARTICLE III. Requirements for Graduation.

No person, whether a graduate in medicine or not, shall be given a diploma of "Doctor of Medicine" who shall not have filled the following requirements, *except* as hereinafter provided for in Article IV:

1. He must produce satisfactory evidence of good moral character, and of having attained the age of twenty-one years.

2. He must file a satisfactory evidence of having studied medicine for at least three years under a *regular* graduate, or licentiate and practitioner of medicine, in good standing, using the word "regular" in the sense commonly understood in the medical profession. No candidate shall be eligible for final examination for graduation unless his term of three years' study shall have been completed, or shall expire at a date not later than three months after the close of the final examinations. This section to take effect at and after the session of 1879-80.

3. He must file the proper official evidence that, during the above-mentioned three years, he has matriculated at some affiliated college or colleges, for two regular sessions, and in the course of the same (except as provided in 4) has attended two full courses of instruction on the seven topics mentioned in Article II. But the *latter*, at least, of the two full courses must have been attending at the college issuing the diploma. No two consecutive courses of instruction shall be held as satisfying the above requirements unless the time between the beginning of the first course and the end of the second is greater than fifteen months.\*

4. In case a college shall adopt a systematic graduated scheme of tuition, attendance on the whole of the same shall be equivalent to the requirements mentioned in 3, *provided* such scheme includes instruction in the seven topics mentioned in Article II, and requires attendance at least at two yearly regular collegiate sessions of not less than twenty weeks' duration each.

5. The candidate must have passed a personal examination before the Faculty on all seven of the branches of medicine mentioned in Article II.

6. He must have *paid in full all college dues*, including the graduation-fee.

\*At a meeting of the American Medical College Association held in New York City, on May 31, 1880, the Articles of Confederation were so amended as to require attendance upon three yearly collegiate sessions as prerequisite to graduation. This requirement will not take effect until the session of 1882-83.

#### ARTICLE IV. Of Honorary Degrees.

An honorary degree of "Doctor in Medicine" may be granted, in numbers not exceeding one yearly, to distinguished physicians or scientific men of over forty years of age. But in such case the diploma shall bear across its face the word "Honorary" in conspicuous characters, and the same word shall always be appended to the name of the recipient in all lists of graduates.

#### ARTICLE V. Of Fees.

SEC. 1. All fees shall be paid in lawful money, and no promissory notes or promises to pay shall be accepted in lieu of cash for payment of fees.

SEC. 2. No ticket or other certificate of attendance upon college exercises shall be issued to any student until the dues for the same shall have been fully paid.

SEC. 3. The established fees for the exercises of the regular session—except the matriculation-fee, graduation-fee, fee for dissections—may be reduced not more than one half to graduates of other affiliated colleges of less than three years' standing, and to undergraduates of the same who have already attended two full courses of the instruction of the regular session.

SEC. 4. The same fees may be remitted altogether to a college's own alumni, to graduates of other affiliated colleges of three years' standing (the three years dating from the time of graduation, and ending at the close of the regular session for which the tickets are given), to undergraduates who have already attended two full courses of the instruction of the regular session, the latter of which at least shall have been in the college making the remission, and to theological students when not candidates for a diploma.

SEC. 5. The same fees may be reduced or remitted to deserving indigent students, to a number not exceeding *five* per cent of the number of matriculates at the previous regular session of the college.

SEC. 6. Under no circumstances whatever, other than the above, shall the faculties, or any members of the same, grant *upon their own authority* any remissions or reductions of established fees; and it is distinctly understood and agreed that the faculties will discountenance and oppose the authorizing, by governing boards, of the admission of individual students on other than the regularly established charges for their grade.

SEC. 7. Remission or reduction of fees for other exercises than those of the regular session, return to a student of any moneys after payment of fees, or an appropriation of funds of the college for payment of any student's fees, or part thereof, shall be deemed a violation of the provisions of this article in regard to remission or reduction of fees.

#### ARTICLE VI. Of Recognition of Other Colleges.

No college shall admit to the privileges accorded in Articles III and V the students or graduates of any college which, during any period of the student's or graduates pupilage, shall have been excluded from the list of affiliated colleges recognized by the Association.

#### ARTICLE VII. Advertisements.

No college shall advertise in any other than a strictly medical publication the names of its professors, with their respective chairs.

#### ARTICLE VIII. Amendments.

Amendments to these articles shall be proposed and adopted in the manner prescribed for amendments to the Constitution.

Good boarding can be procured in the vicinity of the College at from \$3.00 to \$5.00 per week, fire and light included.

Students on their arrival in the city by proceeding to the University, on corner of Eighth and Chestnut streets, within a few squares of the Louisville & Nashville Railroad Depot, will find the Janitor, who will conduct them to suitable boarding-houses.
