## ANNOUNCEMENT.



STARLING MEDICAL COLLEGE enters upon its thirty-fifth year with increased strength and efficiency. Its conspicuous advantages are being more widely recognized, and the honorable record of its graduates, scattered throughout the Union, continue to support its claims to a solid and well-earned reputation. While the College was among the earliest to join in the efforts of the American Medical College Association to raise the standard of medical education, its classes have steadily increased in size, the last being the largest for a number of years.

Placed in the Capital of the State, possessing the finest College building in the country, and a perpetual charter, it has every guarantee of permanence. Every advantage is offered to the student that can be found elsewhere, and at as little cost as is compatible with a thorough equipment and maintenance of the College.

### CLINICS.

This is the only College in the State which has a Hospital of its own. The St. Francis Hospital of Starling Medical College is a well appointed institution, having 100 beds, situated in the College building, so that patients can be conveniently brought before the class, even when suffering from severe acute disorders. Medical and surgical clinics are held weekly throughout the year. Clinical instruction is also given in the wards of the Hospital. During the past year nearly all the diseases which occur in this climate were represented in the wards and brought into the Clinics. This being also the only general Hospital in the city, recent accidents of a surgical nature are brought to it in great number and variety, and its wards constantly contain abundant material for clinical instruction in surgery, as well



as general practice. The clinical resources of the Ohio Penitentiary and Franklin County Infirmary are also free to our students.

A large and completely furnished Morgue has recently been added to the Hospital, where post mortem examinations are made before the class, and frequent opportunities are given to the student to perform the examination himself, and thus become familiar with this important method of investigation.

#### MUSEUM AND LIBRARY.

The Museum of the College contains everything that is necessary to illustrate the various branches of medical teaching, and is daily increasing. It has also many objects of interest to the naturalist as well as to the physician, and is especially rich in the department of Comparative Anatomy. It is provided with several microscopes, including a fine binocular microscope, completely equipped.

A commodious apartment on the ground floor is devoted to the Library and Reading-room. It contains nearly two thousand volumes, comprising the standard medical works and many rare books of reference. Several handsome donations have been made to it, and it now bids fair to become an institution of great value not only to the College but to the professional in general.

#### SPECIAL SUBJECTS.

The Physiological Laboratory has proved an important aid to instruction in that department.

Advanced students will find every opportunity for instruction in the use of the microscope, ophthalmoscope, sphygmograph, and other instruments of precision and diagnosis, and in physiological and chemical work, under competent instructors.

Special attention is paid to Urinalysis, with practical work in the Chemical Laboratory.

Since our last announcement the subjects of Ophthalmology and Insanity have been assigned to teachers of ability in those departments.

## COURSE OF INSTRUCTION.

The voluntary system of graded instruction has been on trial for a sufficient time to test its merits and demerits. While we continue to recommend attendance upon three courses, without preliminary study, we have found it best to insist upon the continuous study of the whole curriculum, with final examinations in all departments at the end of three years. Special attention should be given, during the first year, to Anatomy, Physiology, Chemistry, Materia Medica, and Dissections. Attendance upon three years' lectures does not entail extra expense in fees, there being at present no charge, except for matriculation, during the third year.

## REGULAR AND PRELIMINARY SESSION.

The next regular session will begin on Thursday, September 1st, 1881, and continue six months.

The preliminary session, formerly held in September, is therefore merged in the regular course, that more time may be given to all the departments of medicine. Prompt attendance upon the beginning of the session will be required.

The dissecting-rooms will be open early in the term, under the direction of the Demonstrator, who will furnish material at a moderate cost. The rooms are well lighted by a sky-light and furnished with gas, water, charts, and diagrams necessary for full illustration of this important branch of medical education.

As a result of the passage of the recent anatomy act, material is more easily obtained; and owing to the great efficiency of the Demonstrator and his assistants, we have had an *abundance* of material, and can guarantee the same in the future.

## REQUISITES FOR GRADUATION.

The candidate must have attained the age of twenty-



one year; devoted three full years of study with some reputable practitioner of medicine, including lecture terms; attended two full courses of medical lectures, one of which shall be at this institution; or have attended our full three years' course, which is much the better plan.

During and after the session of 1882-3 attendance upon three full courses of lectures will be required of every candidate, in compliance with a resolution passed by the American Medical College Association, at their last meeting.

At least one course of practical dissection will be required, and a successful examination passed before the Faculty and officers of the College. Certificates of time of study will be necessary.

The presentation of a thesis will be required.

For rules concerning graduates of other Colleges, and all other matters in this connection, see the rules of the American Medical College Association, to which we conform in all particulars.

The Alumni Association will meet on the evening of February 22d, 1882, at the College.

The Board of Censors will meet on Monday of Commencement week, participate in the examinations, thesis-reading, and final exercises, and award prizes.

#### PRIZES.

The Faculty offer a prize of \$50.00 for the best written and best defended thesis, to be awarded by the Board of Censors during Commencement week. The chair of Practice offers a prize of \$25 for the best report of his clinical lectures. The chair of Physiology will give a gold medal to the graduate whose standing is highest in this department.

#### BOARDING.

Good board, including light and fuel, costs from \$3.00 to \$5.00 per week. The whole course need not cost more than \$150.00. Books, instruments, etc., can be obtained at the usual students' rates.

It is with deep regret that we record the death of FRANCIS CARTER, M.D., Emeritus Professor of Obstetrics, and for many years Secretary of the Board of Trustees and

Dean of the Faculty. It was mainly through his influence that the College was founded, and for several years before his death he was the sole survivor of the original Faculty. His wise counsel and paternal kindness endeared him to all his associates, and his departure will be mourned by them and all friends of the College.

The office of Dean has been wisely filled by the election of STARLING LOVING, M.D., Professor of the Practice of Medicine, a graduate of the class of 1849, and for many years closely identified with the College. From his well-known energy and ability, we may safely predict a season of progress and success for the institution over which he has been called to preside.

## ARTICLES OF CONFEDERATION.

## ARTICLE I.—OF THE FACULTY.

The medical members of the Faculty must be *regular* graduates or licentiates and practitioners of medicine in good standing, using the word "regular" in the sense commonly understood in the medical profession.

## ARTICLE II.—OF TUITION.

SECTION 1. The scheme of tuition shall provide for a yearly, systematic course of instruction, covering the general topics of Anatomy, including Dissections, Physiology, Chemistry, Materia Medica, and Therapeutics, Obstetrics, Surgery, Pathology and Practice of Medicine. The collegiate session, wherein this course is given, shall be understood as the "regular" session.

SEC. 2. Said regular session shall not be less than twenty weeks in duration. This section to go in force at and after the session of 1879-80.

SEC. 3. Not more than one regular session, counting the regular session of the two courses of instruction required for graduation, shall be held in the same year.

## ARTICLE III.—REQUIREMENTS FOR GRADUATION.

No person, whether a graduate in medicine or not, shall be given a Diploma of "Doctor of Medicine" who shall not have fulfilled the following requirements, *except* as hereinafter provided for in Article IV:

1. He must produce satisfactory evidence of good moral character, and having attained the age of twenty-one years.
2. He must file a satisfactory certificate of having studied medicine for at least three years under a *regular* graduate, or

licentiate and practitioner of medicine, and in good standing, using the word "regular" in the sense commonly understood in the medical profession. No candidate shall be eligible for final examination for graduation unless his term of three years' study shall have been completed, or shall expire at a date not less than three months after the close of the final examination. This clause to take effect at and after the session of 1879-80.

3. He must file the proper official evidence that during the above mentioned three years he has matriculated at some affiliated college or colleges for two regular sessions, and in the course of the same (except as provided in 4) has attended two full courses of instruction on the seven topics mentioned in Article II. But the *latter*, at least, of the two full courses must have been attended at the college issuing the Diploma. No two consecutive courses of instruction shall be held as satisfying the above requirements, unless the time between the beginning of the first course and the end of the second is greater than fifteen months.

4. In case a college shall adopt a systematic, graduated scheme of tuition, attendance on the whole of the same shall be equivalent to the requirements mentioned in 3; *provided*, such scheme includes instruction in the seven topics mentioned in Article II, and requires attendance at least two yearly regular Collegiate Sessions of not less than twenty weeks' duration each.

5. The candidates must have passed a personal examination before the Faculty on all seven of the branches of medicine mentioned in Article II.

6. He must have paid in full all College dues, including the graduation fee.

#### ARTICLE IV.—OF HONORARY DEGREES.

An honorary degree of "Doctor of Medicine" may be granted, in numbers not exceeding one yearly, to distinguished physicians or scientific men of over forty years of age. But in such case the Diploma shall bear cross its face the word "Honorary," in conspicuous characters, and the same words shall always be appended to the name of the recipient in all lists of graduates.

#### ARTICLE V.—OF FEES.

SECTION 1. All fees shall be paid in lawful money, and no promissory notes or promises to pay shall be accepted in lieu of cash for payment of dues.



SEC. 2. No ticket or other certificate of attendance upon College exercises shall be issued to any student until the dues for the same shall have been fully paid.

SEC. 3. The established fees for the exercises of the regular session, except the matriculation fee, graduation fee, fee for dissections, may be reduced not more than one-half to graduates of other affiliated colleges of less than three years' standing, and to under-graduates of the same who have already attended two full courses of the instruction of the regular session.

SEC. 4. The same fees may be remitted altogether to a College's own Alumni, to graduates of other affiliated Colleges of three years' standing (the three years dating from the time of graduation and ending at the close of the regular session for which tickets are given,) to under-graduates who have already attended two full courses of the instruction of the regular session, the latter of which, at least, shall have been in the College making the remission, and to theological students when not candidates for a diploma.

SEC. 5. The same fees may be reduced or remitted, to deserving indigent students, to a number not exceeding five per cent. of the number of matriculants at the previous regular session of the College.

SEC. 6. Under no circumstances whatever, other than the above, shall the Faculties, or any number of the same, grant, *upon their own authority*, any remissions or reductions of established fees. And it is distinctly understood and agreed that the Faculties will discountenance and oppose the authorizing, by governing Boards, of the admission of individual students upon other than the regularity established charges for their grade

SEC. 7. Remission or reduction of fees for other exercises than those of the regular sessions, return to a student of any moneys after payment of fees, or an appropriation of funds of the College for payment of any student's fees, or any part thereof, shall be deemed violation of the provisions of this Article in regard to remission or reduction of fees.

#### ARTICLE VI.—OF RECOGNITION OF OTHER COLLEGES.

No College shall admit to the privileges accorded in Articles III and V the students or graduates of any College which, during

any period of the student's or graduate's pupilage, shall have been excluded from the list of affiliated Colleges recognized by the Association.

ARTICLE VII.—AMENDMENTS.

Amendments to these Articles shall be proposed and adopted in the manner prescribed for amendments to the Constitution.
