CI Portal closing June 30, 2023

The CI Portal will be permanently closing for school access on June 30, 2023, as it will be replaced with a new data collection, the AAMC Curriculum Survey. For questions about curriculum resources, support, or data collection, please reach out to <u>curriculum@aamc.org</u>.

Managing CI Portal users for schools

- 1. A user should only be assigned one role. If multiple roles are assigned AAMC staff will remove the lowest level role. For example, if the CI Primary Admin and CI Viewer role are assigned to the same user, AAMC staff will revoke the CI Viewer role.
- 2. Each school should designate only one Curriculum Dean.
- 3. All CI Portal users will be able to view all school but only the Curriculum Dean and the CI Primary Admin will be able to manage user access. To view or manage access from the CI Portal select the **User Management Tool (UMT)** in top navigation.
- 4. At this point you will leave the CI Portal application and be transferred to the UMT tool to view or manage access depending on your role.
- 5. The UMT toolbar at the top of the page has four tabs:



- a. **Users**—All users will be able view all active CI Portal roles here (including expiration dates of the roles), and users that can manage access will be able to grant, extend, and revoke roles from here.
- b. **Home**—If you have access to other AAMC applications using UMT (e.g., VSLO) this will take you back to a list of applications to manage access for those applications.
- c. **Invitations**—If you have access to User Management Tool this is where you can grant CI Portal access to a new user(s).
- d. Back to Application—this will take you back to the CI Portal.

Viewing an existing CI Portal user (available to all CI Portal roles)

1. In the Users tab, all active role holders will be listed in the User Details table:

- a. Clicking anywhere on the row will expand the row to show additional details, including a list of all Active and Inactive roles for that specific individual user.
- b. If the user has too many active or inactive roles to display you will see a View All Roles link that will open up all the Active and Inactive roles in new window.
- c. Click anywhere on the row to collapse the expanded row details.

Modifying an existing CI Portal user – grant additional roles, extend, or revoke roles for existing users (available to only the Curriculum Dean and CI Primary Admin)

From the User Details table administrator role holders can manage the following:

- 1. Grant additional roles to existing users
 - a. To grant additional roles to an existing user select Grant Roles from the Actions \checkmark menu. Choose the roles you wish to grant to that user and click Grant Roles. The user will receive a notification that new roles have been granted.
- 2. Extend roles for existing users
 - All roles have an expiration date, but the administrator can extend the expiration date in order to avoid users being locked out. As the expiration date nears, select Extend Roles from the Actions menu to immediately extend the expiration date for one year. The individual will receive a notification that their role(s) have been extended.
- 3. Revoke roles for existing users
 - To revoke one or more of the Active roles for a user, select Revoke Roles from the
 Actions wdot menu. A new window will open for you to select one or more roles to revoke.
 Choose which roles to revoke and click Revoke Roles. No notification is sent to the user when a role is revoked.
 - b. To reverse a revoke action, you can grant a new role or invite the user as described above.
- 4. Extend or revoke roles for multiple users
 - a. Select two or more rows using the 🔲 boxes, then choose Bulk Extend or Bulk Revoke from the Bulk Actions menu



5. To revoke a Curriculum Dean user role, please email curriculum@aamc.org

Inviting a new user to the CI Portal

- 1. In the **Invitations** tab, click on the "Invite User" button.
- 2. Select the role you wish to grant (e.g., CI Viewer).
- 3. Input the user's first name, last name, and address.
- 4. Click the "Notify me when redeemed" box to know when the invitation is activated.
- 5. Invitation access codes are valid for 28 days from the date they are issues.

6. Click the "Send Invitation" button.

Managing invitations to the CI Portal

- 1. Once an invitation is sent, it will appear in the Invitations tab listed as "Active."
- 2. You can choose to "Manage" an individual invitation, which will allow you to "Resend" or "Revoke" the invitation by clicking on the "Actions" tab in the last column of the **Invitations** table.
 - a. If details in the original invitation were not accurate (e.g., sent to the wrong email address), you can "Revoke" the invitation and create a new invitation with the correct information.
 - b. Revoking an invitation revokes the original access code sent via email to the invited user. If an invited user attempts to redeem a revoked invitation, they will receive an error message that the access code is not valid.
 - c. If you select "Resend," the invitation will resend with the original details (first name, last name, email address) provided.
- 3. Invitations that are redeemed will appear in your list of invitations sent. No further action is needed to grant access to the CI Portal to the user.
- 4. Invitations that are revoked will appear in your Invitations list.

To edit the name or email address of an AAMC account

Once signed into an AAMC webpage/application (e.g., the CI Portal, or other AAMC pages/products beyond the CI, etc.), you can navigate to the upper right-hand corner. Then click your name and select "My Account" from the drop-down menu. There, you can edit some user account details and click "Save," or select "Need help?" for further assistance. For general assistance with your AAMC account, beyond CI applications (such as resetting your password or unlocking your account), please see these frequently asked questions, or contact constituenthelp@aamc.org.

Accounts and roles must belong to a real person

Each account and role for the AAMC CI must belong to a real person and include a first and last name. Please do not use or create any 'alias' accounts with an email address that multiple users have access to – this is a security risk. Each person who wishes to have and is eligible for access must have their own account with an email address that they can access.

Curriculum reports for schools

Overview

In the CI Portal, navigate to the "Reports" tab on the top navigation bar. In this tab, reports are organized into categories:

- 1. Previous Verification Reports
- 2. Previous Accreditation Support Reports
- 3. Reports requested by your school
- 4. National curriculum reports
- 5. Curriculum Inventory Data Tool (CI Data Tool)

Your school's access to curriculum reports is determined by your CI participation – more reports are available for schools who contribute to the CI data set.

When interpreting data, we must be cautious to appropriately frame what can be inferred. The CI shows us what schools have documented in their curriculum; it may be that additional or different curriculum exists that was not documented in a manner expressed in a given report. When referencing CI data, it is important to note that while we can say X% of curriculum was documented, it does not mean the inverse (Y%) does not exist. For example, if we find that 80% of schools documented transgender patient care within their curriculum, we *cannot* assume that means 20% of schools do not have any curriculum related to transgender patient care.

School-specific reports

The Verification and Accreditation Support Reports reflect a school's own data, formatted into data tables. The Accreditation Support Report contains data tables formatted to align with the Liaison Committee on Medical Education (LCME) Data Collection Instrument (DCI), which may support schools in the accreditation process. The primary function of these school-specific reports is to confirm that a school's curriculum data is accurate and complete and identify whether adjustments to how school's data is documented are needed to reflect an accurate and complete curriculum. Schools may also find these reports and data tables useful for internal program evaluation and continuous quality improvement purposes. Samples of these reports are available for download in Appendix A.

The Liaison Committee on Medical Education (LCME) has a limited number of specific instructional and assessment methods it wishes schools to report on when completing the Data Collection Instrument (DCI) for accreditation. Previous Verification and Accreditation Support Reports

Your school's previous Verification and Accreditation Support Reports, up to the last 10 years, are available in the "Previous Verification Reports" and "Previous Accreditation Support Reports" tabs. The reports are only available for the years in which a school successfully uploaded CI data, as the reports cannot be created without a school's data. The Accreditation Support Report is only available

from 2020 onward, as 2020 is the first year this report was offered.

Once you select "Previous Verification Reports" or "Previous Accreditation Support Reports" from the "View" drop-down menu, you will see a table with three fields:

- 1. Report Year.
- 2. Verification Report (or Accreditation Support Report) Download. This a downloadable PDF file per academic year.
- 3. Verified Date. This is the date upon which a school verified their CI data to officially share it with AAMC. Because this date is manually entered by AAMC staff, it is only available from 2017-2018 onward, as 2018 is the first year this service of providing previous Verification Reports was offered.

Reports requested by your school

Once you select "Reports Requested by Your School" from the "View" drop-down menu, you will see data requests requested by your faculty and fulfilled by AAMC staff. These are available only to AAMC-member schools.

National curriculum reports

Once you select "National Curriculum Reports" from the "View" drop-down menu, you will see a variety of national aggregate curriculum reports.

Curriculum Inventory Data Tool (CI Data Tool)

The CI Data Tool is an Excel-based annual report designed to make national curriculum data accessible to curriculum deans in a self-serve manner. Medical schools that choose to participate in the CI season for academic year 2021-2022 will have the opportunity to receive the CI Data Tool in November-December 2022. A sample of this report is available for download in Appendix A.

Medical schools interested in receiving the CI Data Tool must submit the Opt-in Survey, which collects feedback on the extent to which medical schools wish to share their data in the CI Data Tool. An invitation for the Opt-in Survey is sent to medical schools each year at the start of the CI season (August 1).

To receive access to the CI Data Tool, medical schools must do two things by October 21: (1) successfully participate in the CI data upload and (2) submit the CI Data Tool Opt-in Survey. More information about the CI Data Tool is available in our <u>Frequently Asked Questions</u>.

Intended use of curriculum reports

AAMC curriculum reports, whether school-specific or in aggregate, are intended for internal institutional use. These reports can support:

- 1. Program and course evaluation
- 2. Continuous quality improvement
- 3. Benchmarking against national trends
- 4. Accreditation

These reports can be shared among faculty at your school for internal institutional use. These reports

should not be shared with other institutions, societies, or external groups. If other schools or societies are interested in these reports, please refer to them <u>curriculum@aamc.org</u>. If you or your faculty are interested in using or citing AAMC curriculum report data externally, for example in a scholarly work, please contact <u>curriculum@aamc.org</u>. Reports may not be used for commercial or for-profit purposes.

Report availability depending on CI participation

Schools will upload their CI data between August 1-October 21, 2022. Once a school successfully uploads and verifies their CI data), schools have access to curriculum reports.
