AAMC, hospital groups file lawsuit over illegal rule mandating public disclosure of individually negotiated rates

The AAMC and three national organizations representing hospitals and health systems sued the federal government this week, arguing the Centers for Medicare and Medicaid Services (CMS) does not have the authority to require and enforce disclosure of individual negotiated rates between hospitals and insurers. "Patients deserve to have the most relevant information when they are making decisions about their health care. Unfortunately, CMS' final rule will only create confusion for patients. We urge CMS to work with us to find the best way forward," said David Skorton, MD, AAMC president and CEO, in a joint statement. Read More

AAMC statement on Ways and Means Committee surprise billing agreement

Following the announcement of an agreement between leaders of the House Ways and Means Committee on a plan to address surprise medical bills, Karen Fisher, JD, AAMC chief public policy officer thanked committee leadership for reaching an agreement on a strategy to address surprise medical bills. "The AAMC will continue working with all lawmakers and other stakeholders to advance policies that protect patients from surprise medical bills and preserve patient access to the vital services provided by teaching hospitals and physicians," she noted in a statement. David J. Skorton, MD, AAMC president and CEO, issued a statement on the House passage of H.R.3, the Elijah E. Cummings Lower Drug Costs Now Act of 2019, noting "the nation's teaching hospitals continue to care for an increasing number of patients who are unable to afford their medications. [...] "We applaud efforts by the House of Representatives to address this problem impacting Americans." Read More
