Department Administrator Interest Group Update

Activities this year:

- Group officially established in September 2019
- Held 2 focus groups with 100-120 participants each.
- Launched an Administrator Listserv (over 550 participants registered).
- Completed initial survey to guide strategic topic areas and priorities that will be used to plan future activities, e.g. moderated town halls, webinars, etc.
- Established a DA Group Advisory Committee, that honed our initial priority areas from the survey and developed an information sheet describing the goals for this Interest Group; this document can be found on the AAMC GBA DA webpage.
- Planned a Spring Webinar (postponed): So, What Do You Do?: The Roles and Value of Department Administration; Speakers: Susan Kline (Duke) and Brian David (Mount Sinai)
- Record number of administrator submissions for breakout sessions, posters, and hot topic sessions planned for the 2020 Spring Meeting.
