Content Update

What's New for the 2026 MyERAS® Application

MyERAS[®] application updates are made every season based on research and community feedback. All changes are intended to improve the application process for applicants and programs and support holistic review. Several updates were made this year to streamline information in the application. Please review these changes in detail on the <u>What You Need to Know About the 2026 ERAS Application Season</u> webpage.

Please note: The ERAS language as it applies to applicants' training interruptions focuses on extensions and interruptions related to academic or professional performance issues and is not intended to solicit information about applicants' health, disability, or family status.

For this section, academic is specified as repeated or remediated coursework, and professional performance issues are specified as professionalism sanctions or any other adverse actions by an applicant's medical school or its parent institution.

Please note that applicants may have leaves or extensions due to factors that are not included in these two questions. More information about an applicant's extensions, gaps, or interruptions may be available in the MSPE, the MyERAS experiences section, personal statement, and programs can also seek clarification through the interview process.

Specialty Questions

Residents applying to Anesthesiology, Neurological Surgery, and Plastic Surgery-Integrated will be required to provide responses to specialty-specific questions before sending applications to programs in these specialties. ERAS Program Management

To receive applications in the ERAS system, programs must register to indicate that they will have open positions and will use the ERAS program. Programs are encouraged to update their participation status for the upcoming ERAS season before the current season ends on May 31.

Program Signal Opt Out

Specialties participating in program signals will automatically have their participation status set to "yes." Programs can opt out by selecting "no." The deadline for opting out is as follows, based on program cycles:

- a. July Cycle: June 18, 2025, at 5 p.m. ET
- b. September Cycle: Aug. 20, 2025, at 5 p.m. ET
- c. December Cycle: Oct. 29, 2025, at 5 p.m. EST

Please note that participation status cannot be updated after the deadlines listed above for each program cycle.

Thalamus Opt In

Programs are automatically opted in to use Thalamus Cortex, Core, Itinerary Wizard, and Cerebellum when they complete registration for the 2026 ERAS season. Bulk onboarding to Thalamus will begin on Wednesday, June 4, 2025, when the 2026 ERAS season opens. Thalamus Application Programming Interface (API)

The AAMC and Thalamus API streamlines transfer of program/applicant data between the ERAS PDWS and Thalamus products. Only users with institution super user (ISU), alternate institution super user (AISU), program super user (PSU), alternate program super user (APSU), and program coordinator (PC) roles in the PDWS have access to authorize data to Thalamus. It is recommended that programs choose the Selected to Interview status to track applicants who are selected for an interview after reviewing their applications. Once the status is selected, programs can filter for this status to view the applicants who were selected for an interview. Selecting this status is optional, so programs can also choose custom statuses or filter for additional criteria.

Note: The authorize and export process can be completed multiple times to accommodate additional/new applications, and no data will be duplicated and/or deleted. Data can also be managed and/or deleted through Thalamus products.

New!

An authorization status will now be displayed on the PDWS applicant details page under the header section. This enables programs to monitor their authorization status and resend the data authorization request to Thalamus if necessary. Additionally, programs have the option to filter applicants based on their authorization status. The filters are listed above in the filter update section.

Managing Screened Data Fields

In the 2026 ERAS season, PSUs and APSUs have the option to update six screened data fields, and ISUs and AISUs can update all 14 screened data fields. Programs in specialties that are participating in geographic preferences screening will not have access to view applicant geographic preferences.

Note: Screened data fields will carry over into Thalamus.
