#### **Describing the Nominee**

A. All AAMC awardees and honorees are expected to meet the AAMC's standards of professional ethics and scientific integrity articulated in our policies. (Standards of Professional Ethics and Scientific Integrity. Leaders of a professional community must embody the professional ethics expected of that community, including through demonstrating respect for the people they work with and serve, deliberate efforts to improve the value and rigor of their work through inclusion of diverse teams and perspectives, and unwavering discipline regarding the quality, integrity, and trustworthiness of their professional achievements.
