Advocacy and Social Justice in Medical School Admissions Working Group

2020-21 COA Survey Review

Surveyed admissions deans/directors, 62/157 (40%) responded

- *45% admissions processes place a high level of importance on applicant experiences in advocacy and social justice issues
- *69% supported adding "Advocacy and Social Justice Experiences" as a category
- *58% were unsure if their admissions process would change to provide additional (new or existing) weighted consideration

2021 GSA/OSR spring meeting – attendees expressed interest in allowing for subcategories to describe applicant experiences.

The Premed Experience

- Project began in 2020
- Addressed concerns from Premed and HP Advisor Communities
- > Collected, Curated and Answered FAQs in several areas
- Distribution in several venues, through AAMC



The Premed Experience

- Shared document with AAMC
- Planned integration with pre-med navigator resources and other dissemination methods
- New webinar series regarding MCAT with M1 student presenters planned



Differences in Matriculants in Peri-pandemic Era

- Admissions community anticipated variance from previous "norms"
- > Saw differences in coursework, grading, experiences
- Has this translated into noticeable or significant changes in our recent medical students?

Project Background

- 2019/2020: AMCAS Advisory Committee received feedback from applicants and schools
- Research findings from a dissertation study

Qualitative Data Summers of 2019, 2020, 2021

Literature Review

•20 papers reviewed

Interviews with Admissions Officers

- Summer 2019, 10 interviews
- •Summer 2020, 29 interviews

Interviews with Medical School Applicants

•Summer 2021, 15 interviews

Quantitative Data Summer – Fall 2020

AMCAS data

- Subset of AMCAS data from 2017 2019
- N = 134,317 unique individuals
- Variables relating to the following categories:
- Demographics (e.g., race/ethnicity, age, gender)
- Citizenship / Residence (e.g., immigration status, rural)
- o Experiences (e.g., military, work)
- Financial / Family History (e.g., SES, family circumstances)



Key Findings (not comprehensive)

Literature Review

- What does "disadvantaged" mean?
- How do admissions committees use?

Applicants

- Unclear definition of disadvantaged
- What to include?
- Purpose in the process?

Admissions Officers

- Want descriptions of kinds of hardships; more info
- Concerns: no clear definition or guidelines; stigma attached to "disadvantaged"

AMCAS Data

- Those who self-reported had higher rates of:
 - Financial hardship
 - First Gen
 - Living in rural areas



Outcomes

Revisions to:

- Question name
- Question Introduction
 - Provides more clarity around whether applies
- Question Guideline
 - Will provide broader examples and writing instructions

Implementation Goal: EY 2024 Cycle




