# Data of Interest to GBA Members: Operations Management Survey and Tool

The FY 2022 Operations Management Survey is currently in the field and available for medical schools to submit until Friday, March 10, 2023. Participating medical schools will

receive the corresponding FY 2022 Operations Management Tool at the end of this July.

The Operations Management Tool presents a variety of metrics designed to help senior administrators and other leaders assess the overall health of their medical school and to understand how their medical school compares to other medical schools in key areas of finance, research, and clinical practice. Participating medical schools have relied on the data from the Operations Management Tool to identify areas of strength and weakness, assist in strategic planning, and respond to requests from governing boards.

The Operations Management Survey and Tool are available to medical school deans and members of the Group on Business Affairs through the "METRICS" tab within <a href="Medical-School Profile System">Medical School Profile System</a>. ## Data of Interest to GBA Members: Department Chair Ages

If you are interested in information on the ages of department chairs, there are several reports that you might find helpful. For example, go to <a href="FAMOUS">FAMOUS</a>>Reports>Chair Reports>Average Age by Department and Chair to find data about department chairs at your medical school. You may use the Appointment Snapshot Date field to generate the report to reflect your department chairs as of whatever date you specify. For national data on department chair ages, go to FAMOUS>Reports>National Reports>Faculty Roster Benchmark Reports. Under Template Reports, you will find information on the number of department chairs in particular age breakouts. Under Custom Reports, you will find information on average ages (including average age by gender).

In addition, there are several department chair age reports on the Faculty Roster website. Under the 2022 U.S. Medical School Faculty report (<a href="https://www.aamc.org/data-reports/faculty-institutions/interactive-data/2022-us-medical-school-faculty">https://www.aamc.org/data-reports/faculty-institutions/interactive-data/2022-us-medical-school-faculty</a>), supplemental tables H and I show the average age of chairs by gender and department type and by race/ethnicity and department type. ## AAMC accepting applications for 2023-2024 COD Fellowship Program

AAMC-member institutions will be awarded up to \$15,000 each for programming reflecting innovative contributions to health care delivery that can serve as models for other institutions to address and mitigate the barriers to care associated with telehealth, particularly for communities that are under-resourced with limited access to health care services. ## CMS Awards 200 GME Slots Under Section 126

On Jan. 9, the Centers for Medicare & Medicaid Services (CMS) announced the first award of 200 direct graduate medical education (DGME) and indirect medical education (IME) slots of the 1,000 slots created by the Consolidated Appropriations Act, 2021 (CAA, P.L. 116-260). The CMS posted a list of awards to the DGME website under the Section 126 tab, along with an updated FAQ document. In a statement, the CMS noted that 100 teaching hospitals in 30 states, the District of Columbia, and Puerto Rico received awards. The 1,000 slots added by the CAA will be distributed to four categories of hospitals: hospitals over their cap, rural hospitals, hospitals in states with new medical schools or branch campuses as of Jan. 1, 2000, and hospitals that serve Health Professional Shortage Areas. The CMS will distribute up to 200 slots per year over five years, beginning with the fiscal year (FY) 2023 award. The application period for the 200 FY 2024 slots is now open, with applications due by March 31.

#### AAMC accepting applications for NEXT Grant program

Applications are now being accepted for the AAMC Nurturing Experiences for Tomorrow's Community Leaders (NEXT) Grant program. Successful applicants will propose projects that seek to develop or enhance health and health care initiatives for learners to confront racism and advance health equity in partnership with local communities. The AAMC will award five grants to member institutions that represent accredited medical schools and teaching hospitals, and Accreditation Council for Graduate Medical Education (ACGME)-accredited U.S. residency programs. Grantees will receive up to \$40,000 to support the development or expansion of experiential community-partnered learning opportunities involving medical students, residents, or both. Applications are due April 3.

# AAMC Webinar: Planning for the SFFA v Harvard and UNC SCOTUS Decisions

The Supreme Court of the United States (SCOTUS) is considering two legal cases in which plaintiffs challenge the limited consideration of race and ethnicity in higher education admissions (Students for Fair Admission v. Harvard, Students for Fair Admission v. University of North Carolina). The Court is expected to announce its rulings by the end of the Court's session in June 2023.

In preparation, the AAMC invites you to join us for a webinar on **Tuesday, March 7 from 2-3 p.m. ET** to discuss the importance of these cases to health professional education and practice, walk through possible outcomes, and outline considerations for contingency planning.

## AAMC survey on the use of simulation in medical education

The AAMC has launched a survey of academic medicine institutions to learn more about the use of medical simulation. The survey seeks to inventory the latest simulation technologies, consider the evaluation metrics being used, identify the resources required, and explore how the COVID-19 pandemic has impacted simulation. Every institution's participation is vital to gain an accurate and complete picture of simulation in medical education. A report summarizing the results will be available to the public in late 2023 while institutions that participate will have access to the full results. ## Case study explores AAMC Core EPAs pilot and findings

An article co-authored by the AAMC and published in *Medical Education Online* offers a case study of the AAMC's Core Entrustable Professional Activities (EPAs) pilot program. In 2014, the AAMC published 13 core EPAs that graduating students should be able to perform with indirect supervision when entering residency. A ten-school multi-year pilot was commissioned to test feasibility of implementing training and assessment of the AAMC's 13 Core EPAs, and in 2020–21, a case study was developed to describe pilot schools' implementation experiences.

# New study on physicians' ability to stay current in medical information and practice

A new study published in *Health Science Reports*, co-authored by AAMC experts, examines continuing medical education (CME) and the extent to which demographic, career, and experiential CME-activity variables were independently associated with physicians' satisfaction with their ability to stay current on medical information and practice. The authors found that significant predictors of respondents who were satisfied included — among others — a surgery specialty, an academic affiliation, and participation in professional meetings and journal-based CME. Respondents who self-identified as a race/ethnicity underrepresented in medicine and were between ages 40 and 49 were less likely to be satisfied.

The updated *AAMC Faculty Salary Report*, used by many in the medical education community as a critical planning resource, is now available. This annual report provides detailed compensation information for faculty in 100 departments and specialties based on a 2022 survey of more than 124,000 medical school faculty. The report also provides

decision-makers with the most current and accurate salary data to support strategic planning while also helping individuals make informed decisions about their careers. Read More
