New AAMC journal policies on use of AI in scholarship submissions

The recent advances in artificial intelligence (AI) technology, such as ChatGPT, have touched all aspects of academic medicine, including health professions education scholarship. To provide guidance to authors, the AAMC's two peer-reviewed journals, *Academic Medicine* and *MedEdPORTAL*, have each developed a policy for reporting and disclosing the use of AI tools in journal submissions. An editorial published in *Academic Medicine* examines the journal's approach to thinking about the use of AI tools in developing submissions, and a new policy has been added to the journal's instructions for authors. A new policy has also been added to the submission instructions for *MedEdPORTAL*.
