We recently ran into a situation where a student was scheduled to rotate with a program through VSLO and the educating hospital does not accept affiliation agreements. We escalated the situation to get their legal and contract services involved, however, we were not successful in resolving this issue. The student was not able to attend this rotation.

00:53:09 Hello, everyone. I'm at Mercer University School of Medicine. We require the AAMC agreement for our student's away rotations. Recently we have had a couple of other schools respond to our request for the AAMC agreement that we do not need an agreement as both schools are in VSLO. Can you please offer guidance on that?

00:53:15 We have ran into trouble where our OGC prefers to update an agreement and remove the evergreen term. Most schools now prefer to have a term on the AAMC agreement.

00:55:19 We are a home institution and don't require affiliation agreements for away rotations. This hasn't been an issue with LCME.

In the relationship between a medical school and its clinical affiliates, the educational program for all medical students remains under the control of the medical school's faculty, as specified in written affiliation agreements that define the responsibilities of each party related to the medical education program. Written agreements are necessary with clinical affiliates that are used regularly for required clinical experiences; such agreements may also be warranted with other clinical facilities that have a significant role in the clinical education program.
