Recording Now Available - Reimagining CQI: A Data-Driven Approach to Accreditation and Strategic Planning

The pace of change in health care delivery models, advances in scientific knowledge and technology, and shifts in traditional revenue streams, demand re-imagination of the traditional approach to strategic planning at academic medical centers. Continuous Quality Improvement (CQI), William Deming's well known management model, essentially creates a data-driven approach to rapid and iterative planning and process improvement. CQI is a relatively new LCME accreditation requirement for medical schools. During this webinar, the speakers described how this requirement is being designed to meet the institutional accreditation need and inform strategic planning for operational efficiency and innovation in medical education. AAMC statement on medical school curriculum

AAMC President and CEO David J. Skorton, MD, and Chief Academic Officer Alison J. Whelan, MD, issued a statement on the development of medical school curriculum. "The presence of diversity, equity, and inclusion in medical school curricula is intended to train the next generation of physicians to respond most appropriately to the rapidly diversifying populations that they will serve. Doing so increases the likelihood for better health care and healthy lives for all patients, including individuals who have been historically marginalized by the health care system."

AAMC statement on President Biden's FY 2025 budget proposal

The AAMC issued a statement in response to President Biden's fiscal year (FY) 2025 budget request. "As the AAMC reviews President Biden's FY 2025 budget request, we appreciate the administration's attempts to preserve funding for federal programs and initiatives that are key to improving the nation's health, but we are concerned that the budget request underinvests in the nation's health and public health infrastructure. Federal funding is integral to so many areas where our AAMC-members lead and serve the community such as medical research, clinical care, programs focused on growing the health care workforce, and access to care. It is crucial that the budget is adequately funded."

AAMC joins amicus brief opposing Idaho ban on gender-affirming care

The AAMC joined the American Academy of Pediatrics and more than 20 other health organizations in an appellate amicus brief focused on ensuring that all adolescents, including those with gender dysphoria, receive the optimal medical and mental health care they need. The brief provides background on gender identity and gender dysphoria. It details the professionally accepted medical guidelines for treating adolescents with gender dysphoria, the scientifically rigorous process by which the guidelines were developed, and the evidence that gender-affirming care is effective and saves lives. Because the brief

focuses primarily on adolescents, it does not discuss surgeries that are typically available to transgender adults.

The AAMC and 9 other leading health care and medical associations issued a joint statement in support of diversity, equity, and inclusion (DEI) policies in health care as a means to help improve the health of our nation. "Our efforts to promote DEI seek to address the long-standing and well-documented inequities in our health care system and its impact on the health of our patients and communities. Excellence in patient care cannot exist until we have a physician workforce capable of caring for our patients and their needs holistically, and until the profession of medicine is accessible to all qualified individuals."

New AAMC data snapshot examines long-term trends in U.S. medical school tuition

A new <u>AAMC data snapshot</u> examines tuition and fees revenues at U.S. medical schools. As of fiscal year (FY) 2022, tuition and fees revenues represent around 3% of total revenue for U.S. MD-granting medical education programs with full Liaison Committee on Medical Education accreditation. While a relatively small proportion of total revenue, tuition and fees serve as a direct revenue source that supports essential operational and educational functions and can be critical to maintaining financial sustainability. The research provides key insights that underscore the complex financial forces shaping the affordability and accessibility of medical education. The authors suggest that further monitoring of these trends can aid in learning how the support of other revenue sources will play a role in influencing the cost of medical education.

ABC3 Coalition publishes roadmap for disability inclusive health care

The National Roadmap for Disability-Inclusive Healthcare is a plan created for clinicians to provide the best health care possible to people with intellectual and/or developmental disabilities (IDD). The roadmap provides clear goals and commonsense actions that groups can take to inspire change among both practicing clinicians and clinicians-intraining. Created by the Action to Build Clinical Confidence and Culture (ABC3) Coalition, of which the AAMC is a member, the roadmap includes input from people with IDD, their care partners and caregivers, clinicians, and other health care leaders.

"While primary care physician proximity and recruitment are importantly emphasized in federal and state legislative bodies, to truly solve the rural health crisis, policymakers must also be willing to invest in educational opportunities and anti-poverty programs and address the stigma surrounding mental health and substance use disorders," he writes.

AAMC letter to Wall Street Journal defends diversity in medical school

A letter co-authored by David J. Skorton, MD, AAMC president and CEO, and Alison J. Whelan, MD, AAMC chief academic officer, was published in the Wall Street Journal. The authors assert that a previously published op-ed "mischaracterizes the way medical schools establish curricula, including considerations of diversity, equity, and inclusion. Teaching related to DEI, health equity, and the care of our diverse population supplements, but in no way replaces, a strong focus on the latest science and evidence on human health and disease."

AAMC joins amicus brief on EMTALA pre-emption

The AAMC joined the American Hospital Association and America's Essential Hospitals in a March 18 Supreme Court amicus brief explaining that an Idaho law criminalizes the termination of a pregnancy even when it is medically necessary and required to stabilize a patient under the federal Emergency Medical Treatment and Labor Act (EMTALA). The brief asks the court to affirm the district court's preliminary injunction in a case involving an Idaho statute that makes it a crime for health care providers to terminate a pregnancy without making an exception for stabilizing care, as EMTALA requires. Providers seeking to comply with EMTALA could face felony charges and the loss of their professional

licenses. The brief explains that the threat of criminal and professional sanctions interferes with the exercise of expert medical judgment and intrudes upon the relationship between a patient and their physician.
