#### Data of Interest to GBA Members: Faculty Salary Equity Tool

The Faculty Salary Equity Tool (FSET) is a downloadable tool that allows users to compare total compensation statistics for men and women faculty members across race/ethnicity, degrees, ranks, and department/specialties at your medical school and at medical school cohorts, including public, private, and all medical schools. Including five years of AAMC Faculty Salary Survey data, the FSET provides a broad overview of compensation trends at U.S. medical schools, broken out by gender and race/ethnicity. This tool is a companion resource to the *Exploring Faculty Salary Equity at U.S. Medical* Schools by Gender and Race/Ethnicity and Promising Practices for Understanding and Addressing Faculty Salary Equity publications and related toolkit. The FSET is available to medical school deans, Principal Business Officers, and their Report Institutional User designees on the AAMC Faculty Salary Reports website. If you are interested in access, you can contact your medical school's dean or Principal Business Officer (their permission is needed because the report contains confidential school-level compensation information). To access the FSET, users can log in with their AAMC username and password at mda.aamc.org/mda-fssr/. After logging in, the 2024 AAMC Faculty Salary Equity Tool (FSET) is available for download in the FY 2023 fiscal year of the Faculty Salary Equity Tool (FSET) page. The FSET is released annually in March.

### AAMC joins amicus brief opposing Montana ban on gender-affirming care

The AAMC joined the American Academy of Pediatrics and more than 20 other health

organizations in an appellate amicus brief focused on ensuring that all adolescents, including those with gender dysphoria, receive the optimal medical and mental health care they need. The brief urges the court to affirm the lower court's preliminary injunction in a case that involves S.B. 99, a law that effectively bans health care providers from providing patients under 18 with medically necessary treatments for gender dysphoria. The law defines the provision of such care as professional misconduct, prohibits the use of public funds for such treatments, and subjects health care providers to at least a one year suspension and to private actions for damages. The brief details the professionally accepted medical guidelines for treating adolescents with gender dysphoria, the scientifically rigorous process by which the guidelines were developed, and the evidence that gender-affirming care is effective and saves lives. ### New polling brief examines public perspectives on reparations in America

A new polling brief developed by the <u>AAMC Center for Health Justice</u>, in collaboration with Morning Consult, analyzes the 2024 landscape of state legislation regarding reparations. Reparations, even when broadly defined and not limited to cash payments, are not supported by the majority of the public, and the more time that has elapsed between a historical injustice and the proposed redress, the larger the ideological divide is on

#### Study examines relevance of tenure at U.S. medical schools

A new study published in *Academic Medicine* finds that tenure systems remain well established at U.S. MD-granting medical schools, but the percentage of full-time faculty on tenured or tenure-eligible tracks has declined over the last four decades, with troubling gaps in tenure-eligible appointments between men and women faculty and among faculty by race and ethnicity. Co-authored by William Mallon, EdD, AAMC senior director of strategy and innovation development, and Natalya Cox, MPH, AAMC research analyst, the study concludes that while the rates of tenure have declined among medical school faculty, tenure remains an important mechanism for ensuring academic freedom, especially as some states attempt to regulate the teaching of divisive concepts. The 2023 AAMC Resident Readiness Survey Reports are now available. The Resident Readiness Survey is intended to streamline and standardize the process for program directors to provide feedback to medical schools on the readiness of their graduates for PGY-1 training. Medical schools use the Resident Readiness Survey Reports to assess the effectiveness of preparing students for residency training and for continuous quality improvement of the curricula.
