# Data of Interest to GBA Members: Characteristics of Medical School Faculty with NIH R01 Awards

A new report showing data on selected characteristics of full-time medical school faculty who have received NIH R01 awards has been added to the *U.S. Medical School Faculty* report (available on the <u>Faculty Roster website</u>. To download the report, go to the Trends drop-down and click on the link for "Characteristics of Medical School Faculty with NIH R01 Awards" at the bottom of the list.

The faculty data come from the AAMC Faculty Roster while the NIH R01 awards data come from the NIH awards data set. R01 awards are grants from the National Institutes of Health (NIH) that support health-related research and development. The data span each federal fiscal year from 1983-84 through 2020-21. The analysis is based on the federal fiscal year rather than the academic year in order to align with the NIH calendar. The data include all faculty who had a full-time appointment at any time within the entire fiscal year (as opposed to just those faculty who had a full-time appointment on a specific snapshot date within the fiscal year). As a result, the counts in this report will be higher than the counts displayed in the other tables of the *U.S. Medical School Faculty* report, which show December 31 snapshots.

## Data of Interest to GBA Members: Organizational Characteristics Database

The AAMC Organizational Characteristics Database is an Excel-based report that provides information on several salient dimensions about the organizational characteristics of medical schools, including ownership/control, financial relationship to parent university, community-based status, research intensity, deans' responsibilities other than the medical school, and practice plan information.

The Organizational Characteristics Database also includes information on teaching hospitals' most recently reported primary medical school affiliates. The medical school-teaching hospital affiliations come from the AAMC Annual and Quarterly Surveys of Hospital Operations and Financial Performance as reported by teaching hospital respondents.

The Organizational Characteristics Database is updated annually each June and is <u>publicly available</u>. Questions or feedback about the Organizational Characteristics Database can be sent to ocd@aamc.org.

#### AAMC announces 2024-25 Board of Directors

The AAMC has announced its 2024-25 <u>Board of Directors</u>. The incoming board's term begins Nov. 12, 2024, and will end at the conclusion of Learn Serve Lead: The AAMC Annual Meeting in November 2025. Julie A. Freischlag, MD, chief academic officer and executive vice president of Advocate Health, chief academic officer of Atrium Health Wake Forest Baptist, and executive vice president for health affairs of Wake Forest University, has been elected to serve as chair of the AAMC Board of Directors. She will succeed Lee Jones, MD, dean for medical education and professor of psychiatry at Georgetown

University School of Medicine, who will become immediate past chair. Michael Waldrum, MD, MSc, MBA, chief executive officer of ECU Health and dean of the Brody School of Medicine at East Carolina University, has been named chair-elect and will succeed Freischlag next year. Read More

#### **AAMC statement on Supreme Court decision on EMTALA**

AAMC President and CEO David J. Skorton, MD, issued a statement following the U.S. Supreme Court decision on the Emergency Medical Treatment and Active Labor Act (EMTALA). "The AAMC is pleased that the Supreme Court has reinstated the August 2022 district court preliminary injunction. [...] The [association] remains concerned about restrictive state laws that limit access to comprehensive reproductive health care, interfere in the patient-physician relationship, and put pregnant women's health and lives at risk. We will continue to monitor the proceedings in the case as it returns to the lower courts." Read More

#### AAMC encouraged by SCOTUS decision on mifepristone access

AAMC President and CEO David J. Skorton, MD, issued a statement on the decision by the Supreme Court in *U.S. Food and Drug Administration v. Alliance for Hippocratic Medicine*. "The AAMC is encouraged by today's U.S. Supreme Court ruling in which the court reversed a 5th U.S. Circuit Court of Appeals decision that would have limited access to the drug mifepristone. In an <u>amicus brief</u> to the court, the AAMC had expressed grave concerns about the negative impact on the clinical delivery and research missions of academic medicine that would have been realized if the lower court ruling was allowed to stand." <u>Read More</u>

# U.S. House members introduce resolution designating June 10-14 as Academic Medicine Weeks

On June 11, in honor of the inaugural Academic Medicine Week, Reps. Kathy Castor (D-Fla.) and Brian Fitzpatrick (R-Pa.) recognized the unparalleled contributions of academic medicine to the health of patients, families, and communities nationwide by introducing a resolution in the U.S. House of Representatives. "As we celebrate this inaugural Academic Medicine Week on Capitol Hill, we thank Reps. Castor and Fitzpatrick for shining a light on the critical role that the nation's academic health systems and hospitals and medical schools play in improving the health of our nation," said David J. Skorton, MD, AAMC president and CEO. Read More

#### **AAMC Responds to Finance Committee GME Working Group Proposal**

The AAMC <u>responded on June 21</u> to a proposal on Medicare-supported graduate medical education (GME) drafted by a bipartisan group of Finance Committee Senators and Finance Chair Ron Wyden (D-Ore.) [refer to <u>Washington Highlights</u>, May 24]. The proposal aims to address physician workforce shortages, challenges faced by rural and

other underserved communities to accessing care, barriers to rural physician training, improved data collection and transparency, as well as other topics.

The AAMC response to the proposal recommended that the working group:

- Provide at least 10,000 new, Medicare-supported GME positions in both primary and specialty care.
- Promote expanded development of rural training programs and encourage rural teaching hospitals to apply for new positions.
- Avoid unnecessary and duplicative reporting requirements.
- Refrain from cutting hospital payments to offset the costs of new GME positions, including hospital outpatient department cuts or revisions to indirect medical education.

# New environmental justice polling data from the AAMC Center for Health Justice

In April, the AAMC Center for Health Justice conducted a national poll to gauge perspectives around environmental hazards, environmental injustice, and environmental justice. According to this new polling data, 7 in 10 adults in the United States believe in the goal of environmental justice; however, 8 in 10 are unaware of any federal efforts to advance it. Among the key findings, while U.S. adults believe that lower-income groups (61%) and communities of color (44%) are disproportionately exposed to environmental hazards, significantly fewer report that those same groups bear the burden of environmental injustice (47% and 33%, respectively).†Only 44% of U.S. adults think that communities of color are more likely to be exposed to environmental hazards than white communities, despite significant evidence that they are. #### New MedEdPORTAL Integrated Behavioral Health Education Collection

The new *MedEdPORTAL* Integrated Behavioral Health (IBH) Education Collection equips educators and institutions with curricular innovations to increase collaboration with interprofessional behavioral health teams in undergraduate and graduate medical education. This peer-reviewed collection emphasizes equitable care for all patients and communities by providing health professions educators with the tools they need to train the next generation to address stigma related to substance use and mental health conditions. #### AAMC Center for Health Justice launches Health Equity Inventory

The AAMC Center for Health Justice has partnered with academic medical centers and medical schools for eight years to develop and improve the Health Equity Inventory. The resource is a cloud-based coordination tool to help organizations and their partners organize their health equity work across research, clinical, education, and community engagement missions. # AAMC releases new minimum digital device recommendations to improve patient access to telehealth

In the ever-evolving digital health landscape, the AAMC has developed a core set of functional requirements and recommendations regarding technology and infrastructure. The recommendations will help health care providers select the right devices to furnish a range of telehealth services aiming to address barriers to care, improve access for all patients, promote digital inclusion, and deliver high-quality patient-centered care, particularly in historically marginalized communities. Recognizing that innovations in technology are not static, these best practices for functional requirements have been adapted to both withstand and support future innovations. Read More

#### New AAMC data snapshot examines DEI efforts at U.S. medical schools

A new <u>AAMC data snapshot</u> explores themes and perspectives among medical school faculty on institutional diversity, equity, and inclusion (DEI) efforts and highlights specific actions for leaders to consider. Actions to support and foster DEI are essential to successfully achieving the missions of academic medicine. The promotion of these efforts in medical education is part of a broader movement to dismantle systems of oppression in the United States, such as providing equitable support among medical school faculty with the goal of diversifying the physician workforce. To capture the impact of institutional investment in formal DEI efforts, new questions were added to the <u>AAMC StandPoint</u> Faculty Engagement Survey in 2021 to assess perceptions of diversity and inclusion in the medical school workplace and solicit suggestions for how to improve efforts related to DEI.
