#### **AAMC Comments on ONC's HTI-2 Proposed Rule**

The AAMC <u>submitted Oct. 4 comments</u> to the Department of Health and Human Services (HHS) Assistant Secretary for Technology Policy (ASTP) /Office of the National Coordinator for Health Information Technology (ONC) in response to the Health Data, Technology, and Interoperability (HTI) proposed rule to address patient engagement, information sharing, and public health interoperability [refer to *Washington Highlights, July* 12].

#### Lauren Maggio, PhD, MS, named next editor-in-chief of MedEdPORTAL

Following a nationwide search, Lauren Maggio, PhD, MS, has been named editor-in-chief of the AAMC peer-reviewed journal *MedEdPORTAL*, effective Jan. 1. She succeeds Grace Huang, MD, who has served as editor-in-chief since 2017. *MedEdPORTAL* is a MEDLINE-indexed, open-access journal of teaching and learning innovations in the health professions. Maggio is currently a professor and the director of research in the Department of Medical Education at the University of Illinois College of Medicine in

Chicago. As editor-in-chief, she will provide leadership and strategic vision for *MedEdPORTAL* and will be responsible for maintaining its standard of excellence and continuing to build its international reputation as the most utilized, cited, and influential publication of health education innovations. In this role, Maggio will advance the mission of the journal and will chair the *MedEdPORTAL* editorial board.

# AAMC joins Supreme Court amicus brief opposing Tennessee ban on gender-affirming care

The AAMC joined the American Academy of Pediatrics and more than 20 other national and state medical and mental health organizations in a Supreme Court amicus brief focused on ensuring that all adolescents, including those with gender dysphoria, receive the optimal medical and mental health care they need. The Sept. 3 brief urged the court to vacate the 6th U.S. Circuit Court of Appeals decision upholding S.B. 1, a Tennessee law that prohibits health care providers from providing patients under the age of 18 with medically necessary treatments for gender dysphoria. The brief provided background on gender identity and gender dysphoria and detailed the professionally accepted medical guidelines for treating adolescents with gender dysphoria, the scientifically rigorous process by which the guidelines were developed, and the evidence that gender-affirming care is effective and saves lives. Because the brief focused primarily on adolescents, it did not discuss surgeries that are typically available to transgender adults.

AAMC Research and Action Institute data snapshot highlights clinical benefits of not-for-profit health systems beyond charity care

A new data snapshot from the <u>AAMC Research and Action Institute</u> examines the differences in services offered across health systems and hospitals by profitability status, ownership, and teaching status to better illustrate their benefit provided to communities beyond charity care. The authors highlight the discrepancies in services offered across short-term general and critical-access hospitals and how these discrepancies relate to charity care and the policy implications of defining and interpreting charity care differently across institutions. The data show that not-for-profit hospitals â€" and particularly teaching hospitals â€" were more likely than for-profit hospitals and nonteaching hospitals to offer a comprehensive list of health care services, including unprofitable ones such as trauma and burn centers and psychiatric services.

# New AAMC Research and Action Institute data snapshot examines impact on life expectancy from three preventable causes of death

A new data snapshot developed by the <u>AAMC Research and Action Institute</u> examines how alcohol, drug, and firearm deaths have lowered life expectancy in the United States, which has contributed to the growing gap in life expectancy between the United States and other high-income countries. If deaths due to alcohol, drugs, and firearms were eliminated (and other causes of death remained the same), life expectancy at birth would increase by 1.6 years. Overall, ten states would see a more than two-year jump in life expectancy if these deaths did not occur. The analysis underscores that shortened life expectancy is closely related to preventable causes of death, which can be improved through targeted public health interventions and investments at the national and state levels, such as in mental health and social services rather than direct changes to clinical care.

## AAMC publishes updated competencies report on quality improvement and patient safety

The AAMC has published the *Quality Improvement and Patient Safety (QIPS)*Competencies Report, which outlines the updated framework for integrating quality improvement and patient safety education across medical education continuums. The competencies emphasize patient-centered care, health equity, and interprofessional

collaboration, and the report provides guidance on implementing QIPS in curricula, offering models for assessment and integration into clinical practice. As part of the AAMC's commitment to advancing quality improvement and patient safety, Rosha McCoy, MD, senior director of advancing clinical leadership and quality, represented the AAMC at the White House Healthcare Safety Forum hosted by the Office of Science and Technology Policy on Sept. 17. The forum convened health organization leaders, patient and workforce advocates, health care system executives, and administration officials. Read More

It has approximately 100 terms that medical schools may use in documenting and reporting their curriculum.
