#### AAMC joins amicus brief in Florida gender-affirming care case

The AAMC joined the American Academy of Pediatrics and more than 20 other organizations in an Oct. 9 amicus brief focused on ensuring that all adolescents, including those with gender dysphoria, receive the optimal medical and mental health care they need. The amicus brief, filed with the U.S. Court of Appeals for the 11th Circuit, urged an affirmance of a district court's permanent injunction in *Doe v. Surgeon General, State of Florida*, a case challenging rules created by the Florida Board of Medicine and the Florida Board of Osteopathic Medicine prohibiting health care providers from providing patients under 18 with medically necessary care for gender dysphoria. <u>Read More</u>

#### AAMC joins amicus brief supporting EMTALA in Idaho abortion case

The AAMC joined the American Hospital Association and America's Essential Hospitals in a recent 9th U.S. Circuit Court of Appeals amicus brief explaining that Idaho law criminalizes the termination of a pregnancy even when it is medically necessary and required to stabilize a patient under the federal Emergency Medical Treatment and Labor Act (EMTALA). The brief urged the appellate court to maintain the injunction under which women in Idaho will still be able to obtain an abortion in a medical emergency. Read More

# AAMC-Supported Legislation to Mitigate Physician Cuts Introduced in House

The <u>AAMC-supported bipartisan</u> Medicare Patient Access and Practice Stabilization Act of 2024 (<u>H.R. 10073</u>) was introduced by Reps. Greg Murphy, MD (R-N.C.) and Jimmy Panetta (D-Calif.) on Oct. 29. Original co-sponsors of the legislation include Reps. Mariannette Miller-Meeks, MD (R-Iowa), Raul Ruiz, MD (D-Calif), Larry Bucshon, MD (R-Ind.), Kim Schrier, MD (D-Wash.), John Joyce, MD (R-Penn.), and Ami Bera, MD (D-Calif.).

The legislation would eliminate the looming proposed 2.8% cut to the Medicare Physician Fee Schedule and provide a 1.8% payment update in calendar year 2025, which is a payment increase equal to one-half of the Medicare Economic Index. Without congressional action, this proposed cut will go into effect on Dec. 31. The AAMC and other provider groups oppose this cut and have urged Congress to mitigate it as in years past [refer to <u>Washington Highlights, Sept. 13</u>].

#### Physician Data Initiative: Collaborative Data Sharing

The Accreditation Council for Graduate Medical Education, the American Medical Association, and the Association of American Medical Colleges are collaborating through the Physician Data Initiative, a working group founded to establish a standard practice for categorizing, collecting, reporting, and sharing sociodemographic data. This work is driven by the importance of a diverse physician workforce and a more equitable health system, and <u>recommended standards</u> now available for race and ethnicity and language proficiency. Additional standards are planned for development in the future.

Any organization is free to use the standards. While the goal is not to mandate standards broadly across organizations, there is great benefit to voluntarily adopting mutually agreed-upon values and structure to gather and disaggregate data consistently.
