AAMC statement on the House budget resolution

AAMC President and CEO David J. Skorton, MD, and Chief Public Policy Officer Danielle Turnipseed, JD, MHSA, MPP, issued a statement on the budget resolution ahead of the vote by the U.S. House of Representatives. "As the House considers its fiscal year 2025 budget resolution, we urge lawmakers to protect access to care for millions of hard-working Americans by rejecting policies that could lead to significant cuts to the Medicaid program and limit access to student financial aid for aspiring physicians."

AAMC Joins 600 Organizations in Support of NIH Funding

The AAMC joined 600 organizations in a [Feb. 25 letter \(PDF\)](#) urging House and Senate Appropriations Committee leadership to provide robust fiscal year (FY) 2025 funding for the National Institutes of Health (NIH) and protect against cuts to the agency. Specifically, the letter called on Congress to ensure the NIH receives at least the \$1.77 billion increase proposed in the Departments of Labor, Health and Human Services, and Education, and Related Agencies Appropriations Act, 2025 ([S. 4942](#)). Additionally,

the letter supports the continuation of legislative language prohibiting changes to NIH facilities and administrative cost reimbursements [refer to [Washington Highlights, Feb. 14](#)]. "NIH funding is a key driver of economic growth, job creation, and medical breakthroughs, and this policy change would hinder our ability to remain globally competitive," the letter noted.

AAMC Joins Letter Responding to the Department of Education's SFFA Guidance

The AAMC joined 67 higher education organizations in a [Feb. 25 community comment letter \(PDF\)](#) sent to the Department of Education in response to the department's recent dear colleague letter (DCL) which provided guidance on higher education institutions' civil rights responsibilities following the *Students for Fair Admissions v. Harvard* (SFFA) Supreme Court decision.

AAMC-Supported Letter Urges Support for VA Workforce

The [Friends of the VA Medical Care and Health Research \(FOVA\) Coalition executive committee](#), of which the AAMC is a member, sent a [Feb. 20 letter \(PDF\)](#) expressing concern to House and Senate committee leadership regarding the ongoing federal hiring freeze the recent dismissal of Department of Veterans Affairs (VA) employees and their impact on veteran care, patient safety, and medical research conducted at VA medical centers nationwide. Specifically, the letter urged the administration and congress to halt and rescind the dismissals of key VA medical and research staff and to exempt all roles related to medical care and research from the federal hiring freeze. "These actions are necessary to protect veteran health, maintain medical research momentum, and prevent irreparable harm to VA's ability to deliver high-quality care," the letter noted.

AAMC Joins Amicus Briefs Opposing Executive Order Ban on Gender-Affirming Care

The AAMC [joined the American Academy of Pediatrics and more than a dozen other national and state medical and mental health organizations in two amicus briefs](#) focused on ensuring that all adolescents, including those with gender dysphoria, receive the optimal medical and mental health care they need.

The AAMC joined a Feb. 13 brief urging a U.S. District Court in Maryland to maintain an injunction against a Jan. 28 executive order banning federally supported health care institutions from providing patients under 19 medically necessary treatments for gender dysphoria [refer to [Washington Highlights, Jan. 31](#)]. The District Court entered a temporary restraining order against implementation of the ban as it relates to gender-affirming care for adolescents.

The AAMC also joined a Feb. 25 amicus brief urging a U.S. District Court in Seattle to

issue a preliminary injunction against the executive order's ban on federally supported health care institutions providing patients under 19 medically necessary treatments for gender dysphoria.

AAMC Joins Amicus Brief Urging Supreme Court to Uphold Preventive Care Coverage

The AAMC on Feb. 24 joined the American Hospital Association, the Catholic Health Association, the Federation of American Hospitals, and America's Essential Hospitals to file an [amicus brief urging the Supreme Court to reverse the 5th U.S. Circuit Court of Appeals decision](#) in *Braidwood Management v. Becerra*, which invalidates the Affordable Care Act requirement that private health plans cover, without cost-sharing, preventive services recommended by the U.S. Preventive Services Task Force [refer to *Washington Highlights*, [May 5](#), [May 19](#)].

AAMC President and CEO David J. Skorton, MD, and Chief Public Policy Officer Danielle Turnipseed, JD, MHSA, MPP, issued a statement on the confirmation of Doug Collins as the secretary of the Department of Veterans Affairs (VA). "The AAMC congratulates Doug Collins on his confirmation as secretary of the Department of Veterans Affairs. For nearly 80 years, academic medicine, made up of the nation's medical schools, academic health systems, and teaching hospitals, have forged a robust partnership to advance the health of veterans. â€ The AAMC looks forward to working with Secretary Collins and the dedicated VA staff to build on our impactful and historic partnership to provide high-quality care to those veterans who have bravely and selflessly served this country."

AAMC lawsuit results in nationwide temporary restraining order on proposed drastic cuts to NIH funding

On Feb. 8, AAMC President and CEO David J. Skorton, MD, and Chief Scientific Officer Elena Fuentes-Afflick, MD, MPH [issued a statement](#) in response to an announcement from the new administration regarding drastic cuts to National Institutes of Health (NIH) funding. The AAMC issued a follow-up statement on Feb. 11 regarding a lawsuit led by the AAMC, with other organizations, challenging the legality of the administration's stated plan to make major cuts to federally funded research. "Last night a federal judge in the U.S. District Court for the District of Massachusetts granted the AAMC's motion for a nationwide temporary restraining order, preventing a Feb. 7 notice from the NIH from going into effect. â€ The AAMC is pleased that the court agreed with our assertion that the notice would have resulted in irreparable harm to the research mission, leaving institutions no choice but to scale back research activities. This could mean fewer clinical trials, less fundamental discovery research, and slower progress in delivering lifesaving advances to the patients and

families that do not have time for any delay."

AAMC statement on firings at the U.S. Department of Health and Human Services

AAMC President and CEO David J. Skorton, MD, and Chief Public Policy Officer Danielle Turnipseed, JD, MHSA, MPP, issued a statement regarding firings at the U.S. Department of Health and Human Services (HHS). "We were deeply dismayed to hear reports of broad and, what appear to be, arbitrary firings across many federal agencies and offices directly related to and responsible for the public's health. We urge [HHS Secretary Kennedy] to reconsider these firings so we can leverage the expertise and experience of these trusted, skilled, dedicated civil servants and work with them to improve the health of the nation."

In an op-ed published this week in *USA Today*, AAMC Chief Health Care Officer Jonathan B. Jaffery, MD, MS, MMM, underscores the devastating impact of proposed National Institutes of Health (NIH) cuts to indirect costs on medical research and patient care. He recalls how NIH-funded research has revolutionized treatments and lead to dramatic improvements in survival rates and quality of life for patients, but notes the proposed cuts, should they be enacted, will have far-reaching consequences for medical research, patient care, and the health of communities across the country.

AAMC Lawsuit Results in Temporary Nationwide Restraining Order on Cuts to F&A Rates

The AAMC outlined its main priorities and concerns related to the budget reconciliation process in a [Feb. 21 letter \(PDF\)](#) to Senate Majority Leader John Thune (R-S.D.) and Speaker of the House Mike Johnson (R-La.). The letter follows the release and mark-up of competing budget resolutions by the House and Senate Budget Committees last week [refer to [Washington Highlights, Feb. 14](#)]. The budget resolution represents a first step in the budget reconciliation process, which would provide an expedited process to bypass the Senate filibuster and enact President Donald Trump's domestic policy agenda by a simple majority vote.

AAMC Joins Group Letter Requesting Rescission of HIPAA Proposed Security Rule

The AAMC joined several health organizations in a [letter urging the Trump administration \(PDF\) to rescind](#) the proposed rule "[HIPAA Security Rule to Strengthen the Cybersecurity of Electronic Protected Health Information](#)" and to engage with organizations to develop a more balanced approach that addresses cybersecurity concerns without imposing excessive burdens on the health care sector. While the letter expressed the group's commitment to enhancing cybersecurity, it raised concerns with the impact the staggering costs and regulatory burden of this regulation would have on hospitals and health care systems, as well as the unreasonable timeline. The letter explained that the complexity and scope of the requirements would necessitate substantial investments in time, resources, and personnel to achieve compliance, diverting funds away from other critical areas, impacting patient care.

Refreshed Faculty Data Tables

The *U.S. Medical School Faculty* report has been refreshed to reflect December 31 snapshots of full-time faculty on the Faculty Roster public website (<https://www.aamc.org/data-reports/faculty-institutions/report/faculty-roster-us-medical-school-faculty>). Snapshots are available from 2022 through 2024. The U.S. Medical School Faculty report presents information about the distribution of full-time faculty and department chairs by characteristics such as department, rank, degree, tenure status, gender, race/ethnicity, and age, and about full-time faculty hires, departures, and promotions. In addition, there are several trend reports on the Faculty Roster website showing counts and percentages of full-time faculty, department chairs, and medical school deans over time. There are also trends showing full-time faculty attrition and promotion rates and trends in the average age of full-time faculty and department chairs over time.

AAMC Center for Health Justice explores changes in trust in communities

From 2021 through 2024, the AAMC Center for Health Justice conducted four polls that asked respondents to rate how much they trusted institutions to serve everyone in their local community fairly. A new brief published by the Center presents trust-related findings and insights into changes in trust over time and provides information on the demographic subgroups that report lower levels of trust.
