The AAMC's vast membership network of 160 medical schools and nearly 500 academic health systems and teaching hospitals drives the patient care improvements and cutting-edge research breakthroughs that propel systemic change across the nation's health care system. ## How does academic medicine benefit your state's economy?

Our members are [vital economic engines](#) in California. In 2019, they added \$58.80 billion in value to the state's economy, generating 495,406 jobs. This added value was 1.83% of California's GDP — or \$1,488 per resident. The average job supported by academic medicine in California pays \$82,109.<sup>1</sup>

Nearly 60% of extramural research funded by the National Institutes of Health (NIH) takes place at medical schools and teaching health systems and hospitals, where scientists, clinicians, and trainees work together to advance scientific breakthroughs that improve the lives of millions of Americans.<sup>2</sup> In California, NIH research added \$3.39 billion to the state's economy and 31,259 jobs in 2019.<sup>1</sup>
