# How does academic medicine benefit your state's economy?

Our members are <u>vital economic engines</u> in Missouri. In 2019, they added \$12.09 billion in value to the state's economy, generating 144,475 jobs. This added value was 3.45% of Missouri's GDP — or \$1,970 per resident. The average job supported by academic medicine in Missouri pays \$58,724.<sup>1</sup>

Nearly 60% of extramural research funded by the National Institutes of Health (NIH) takes place at medical schools and teaching health systems and hospitals, where scientists, clinicians, and trainees work together to advance scientific breakthroughs that improve the lives of millions of Americans.<sup>2</sup> In Missouri, NIH research added \$572 million to the state's economy and 7,861 jobs in 2019.<sup>1</sup>
