## NIH Study Sections and Advisory Councils

Updated: May 25, 2025.

- On March 20, the federal register listed the first re-scheduled NIH advisory council
  meeting since late January. Since then, 55 advisory council meetings have been
  scheduled across NIH ICs. Distinct from study sections, the re-scheduling of such
  advisory councils marks an important procedural step that allows new grants to be
  awarded.
- From January through March, the NIH paused communications and cancelled scheduled study sections. Since March 4, approximately 510 study sections managed by the NIH Center for Scientific Review (CSR) have been scheduled to convene throughout April and June, and since March 17, 275 IC-managed study sections have also been announced through the <u>Federal Register</u>.
- These postings follow an announcement by the NIH that <u>all first-level study sections</u> will be managed by the CSR in the future, although the implementation date of this change has not been announced.
