GBA/GIP Webinar: Leveraging AI to Enhance Effectiveness in Administration, Analytics, and Leadership (part of the <u>AI in Academic</u> <u>Medicine Series</u>)

This session on **Thursday, September 25 from 1:00 pm-2:00 pm ET** will highlight key Al use cases aimed at streamlining administrative and operational tasks. First, we will describe the development of DOMINIQ (Dept of Medicine's Interactive Navigator for Inquiries & Queries), a secure chatbot that simplifies access to policies in finance, HR, academic affairs, IT, and more. Next, we will examine how workflows in research administration, clinical revenue, and faculty productivity can be improved by applying Al to Python scripting, complex Excel formulas, and MS Power Automate. Lastly, we will delve into an innovative use case where leaders engage in reflective dialogue with GPT models to enhance their interpersonal communication skills. Overall, this session will provide practical insights into how Al can drive productivity and improvements across various operational areas. *This topic was previously presented at the recent Group on Business Affairs (GBA) and Group on Institutional Planning (GIP) Joint Spring Meeting, and open to any constituents at AAMC member institutions.*

AAMC statement on final passage of the reconciliation bill

AAMC President and CEO David J. Skorton, MD, and AAMC Chief Public Policy Officer Danielle Turnipseed, JD, MHSA, MPP, issued a statement on the final U.S. House passage of the reconciliation bill. "We are profoundly disappointed and dismayed by many of the provisions included in the reconciliation bill passed by the House today. As the Congressional Budget Office has said, massive cuts to Medicaid and changes to state health insurance marketplace exchanges will lead to tens of millions of people losing much-needed health care coverage. Additionally, eliminating the Grad PLUS loan program will affect many prospective medical and other health professions students and worsen the nation's persistent doctor shortage."

AAMC Applauds Introduction of Bill to Reduce Physician Shortage

The AAMC has endorsed the introduction this week of the Resident Physician Shortage Reduction Act of 2025. This bipartisan legislation would gradually add 14,000 Medicaresupported medical residency positions over seven years as well as codify the Rural Residency Planning and Development Program. "As our nation's population ages and the demand for medical care continues to rise, Congress must take immediate action to tackle the critical physician shortage that threatens the health and well-being of our nation," said

A new AAMC analysis focuses on a key area of impact: terminations of research training and career development grants that help build the next generation of the biomedical research workforce. Of 2,282 NIH grants terminated as of June 4, 38% were research training and career development grants, accounting for \$512 million in lost funding across U.S. institutions. Read More
