Dear Chairman Guthrie and Ranking Member Pallone:

As leaders of national organizations focused on protecting the health of the country, we appeal to you to conduct urgent oversight over the abrupt dismissal of Dr. Susan Monarez, the Director of the Centers for Disease Control and Prevention (CDC), and the subsequent resignations of multiple senior leaders at the agency. These departures represent a serious threat to the health and security of our nation. A full, transparent, and public accounting of what transpired is a necessary first step to ensure agencies are providing the best scientific information to Americans, restore trust in our public health agencies, and prevent further damage to the country's health defenses. We were pleased to see planned action in the Senate and hope your committee takes similar steps.

Congress has tasked the Director of CDC, by statute (42 U.S. Code § 242c), with clear authorities and responsibilities. These authorities include the prevention and control of diseases and the management and operations of CDC. In addition to its internal operations, CDC bolsters public health and health care nationwide by issuing guidance to health professionals and the public, operating key laboratories, conducting and supporting research, disseminating data, distributing public health funding appropriated by Congress, and providing technical assistance and on-the-ground support to states, localities, tribes, and territories. Without support from the CDC—both in funding and scientific expertise—state, local, Tribal, and territorial health departments will be left without the resources they need to protect Americans' health. Removing Dr. Monarez, who was confirmed by the Senate just weeks ago, leaves the agency without clear direction and undermines the agency's work to protect the health of individuals in every community.

The resignation letters of several senior CDC experts describe significant vulnerabilities in the nation's infectious disease prevention and control enterprise. These allegations are serious and very concerning. The letters describe substantial interference with the work of CDC's infectious disease centers and well-established science.¹ The agency's workforce must be empowered to

follow the best available science in its research, guidance, and policy. Interference with CDC data and recommendations—whether real or perceived—will further erode trust in CDC and compromise the nation’s health security.

Given your leadership on the Congressional committee with jurisdiction over CDC and public health, we urge you to take the following steps to protect the scientific integrity of our nation’s health protection agency:

- 1) Conduct bipartisan Committee investigations into the circumstances leading to the dismissal of Dr. Monarez and resignations of senior leaders, including the concerns expressed by senior officials regarding vaccine recommendations;
- 2) Hold hearings with the Secretary of Health and Human Services, Robert F. Kennedy, Jr., including related to public health vulnerabilities identified in the resignation letters; and
- 3) Take appropriate corresponding action to prevent similar instability in the future.

Your leadership is critical to ensuring our nation is back on track to be a global leader in health and science and protecting the nation’s health. We stand ready to assist you in this endeavor.
