GSA Student Opportunity, Access, and Retention (SOAR) Committee

In July 2025, the committee formerly known as Committee on Student Diversity Affairs, was renamed the **Student Opportunity**, **Access and Retention Committee**. This new committee name reflects both the evolving focus of our work and our continued commitment to supporting students in and through their academic medicine experience. The acronym **SOAR** is intentional—it symbolizes growth, momentum, and the journey our students take as they enter and move through medical education.



GSA SOAR

This calendar year started with a whirlwind of Executive Orders greatly impacting the work of university Diversity, Equity and Inclusion administrators. It has been a very stressful time for the higher education community and medical schools, in particular. As a result, COSDA (now SOAR) has worked to minimize the negative impact these actions have had on our work and to continue supporting our colleagues and students.

We have continued to focus on developing strategies for Student Diversity Affairs Professionals, collaborate with colleagues on the Promising Practices in Admissions Work Group, and assisting other committees with 2024-2025 priorities to ensure equity needs are being met in all areas across the medical education continuum.

With the recent (May 2025) LCME announcement eliminating Element 3.3, there is still much to do in our efforts to ensure our future physician workforce is reflective of our communities.

Our work this year has included:

- Successful Regional Meeting Sessions:

This document highlights the need for close collaboration between the Financial Aid community and colleagues in the offices of admission, student affairs and medical education in navigating the impact of recent legislative changes on medical students' financial aid policies (One Big Beautiful Bill Act of 2025 (OB3)). Financial Aid officers can serve as a key resource, offering insight, guidance, and support to help other areas anticipate and address the financial implications of OB3. By working together, our shared goal is to ensure that students receive accurate information, timely assistance, and the best possible support throughout their academic journey.

I. Student Aid Policy Changes Affecting Incoming Students: Identifying Scenarios to Engage Financial Aid Offices

(Students starting after July 1, 2026)

- Schools may consider requiring a credit check or statement of financial ability as part of admissions to ensure matriculation readiness.
 - o i.e. credit-worthy co-signer for private loans.
- Schools may consider becoming "need-aware" during the admissions process.


