Data of Interest to GBA Members: Faculty Roster Benchmark Reports
For benchmarking purposes, Faculty Roster representatives have access to
aggregate school-specific information in the Faculty Roster application. Log
in using your AAMC username and password and navigate to
Reports>Benchmarking Reports. The benchmarking reports allow you to
see counts of full-time faculty and department chairs at each U.S. medical
school as of a user-specified snapshot date. The results can be broken out
by various combinations of department type, rank, race/ethnicity, gender,
degree, and age. You can also define a comparison group of medical
schools, such as by public/private status, geographical region, or a list of
peer institutions. You can trend faculty counts going back to 1966 and
chair counts going back to 1977. Data from the benchmarking reports can
be exported to Excel for further analysis (such as calculating percentages).

New AAMC analysis: Nearly 200 hospitals could lose Section 131 GME benefits amid low utilization

A new analysis coauthored by researchers from the AAMC and the University of North Carolina Cecil G. Sheps Center for Health Services Research examines the impact of Section 131 of the Consolidated Appropriations Act, 2021 on certain hospitals' ability to establish or expand graduate medical education (GME) programs by resetting low Medicarefunded resident caps and per-resident amounts. This issue has disproportionately affected rural hospitals and hospitals in underserved areas. Only 23 of 219 hospitals (10.5%) eligible under Section 131 have reset their full-time equivalent (FTE) caps. For most, the five-year window ending Dec. 26, 2025, proved too short to benefit under the complex statutory and regulatory policies surrounding new program development and Medicare GME payment. The expiration of Section 131 may jeopardize the ability of nearly 200 hospitals, especially in rural and underserved areas, to create or expand GME programs, limiting their ability to expand physician training and potentially retain those physicians as they enter practice. Absent Congressional action to extend the policy, hospitals that have not yet taken advantage of Section 131 will lose the ability to do so at the end of December.

The AAMC has developed a collection of Medicaid resources including Medicaid policy developments and related AAMC advocacy, as well as resources specific to implementation of the One Big Beautiful Bill Act (OBBBA, P.L. 119-21). The new page will include relevant information as the Centers for Medicare & Medicaid Services begins to implement provisions of the OBBBA that affect Medicaid financing, provider reimbursement, and access to care. A new resource is also now available, Summary and Implementation Timeline of Medicaid Provisions Within the OBBBA, that summarizes key Medicaid provisions of the OBBBA, implementation deadlines, and anticipated regulatory action.
