1. Senate Appropriations Subcommittee Hearing on the NIH

The Senate Appropriations L-HHS Subcommittee will hold a hearing entitled, "Saving Lives Through Medical Research." The Subcommittee will meet at 10:30a.m. on Wednesday, Mar. 8 in SD-138 of the Dirksen Senate Office Building. A list of witnesses and live webcast can be found <u>here</u>.

2. House Appropriations L-HHS Subcommittee Public Witness Day Hearing

The House Appropriations L-HHS Subcommittee will hold its outside and public witness day hearing on Mar. 8 at 10am in 2358-C Rayburn House Office Building. This hearing is an opportunity for the public to provide their testimony to the subcommittee before it begins work on FY 2018 appropriations. All groups that have been selected to testify in person have already been notified by the subcommittee. 3. Members Voice NIH Support at House Appropriations L-HHS Subcommittee Hearing

The House Appropriations L-HHS Subcommittee Members' Day hearing was <u>held</u> on Mar. 1. Members of Congress provided testimony in favor of NIH funding, including Reps. John Delaney (D-Md.), Sheila Jackson Lee (D-Texas), Robin Kelly (D-III.), and Brian Fitzpatrick (R-Pa.). Chairman Tom Cole (R-Okla.) and Ranking Member Rosa DeLauro (D-Conn.) also reiterated their support for the NIH. Responding to testimony from Rep. Delaney, Chairman Cole stated, "If we can get the '17 bill out, the good news is that we'll have another substantial increase for NIH."

4. STAT Plus: "Key Republican Warns Trump's Budget Plan Could Mean Cuts to NIH"

In a Mar. 3 article, House Appropriations L-HHS Subcommittee Chair Tom Cole (R-Okla.) expressed his concern regarding the impact President Trump's FY 2018 budget proposal may have on the NIH budget. The proposal is expected to seek a \$54 billion increase in defense spending, offset by nondefense discretionary spending. In the article, Chairman Cole explained, "If that happened, everybody is going to be impacted." He went on to say, "I'd be very disappointed if we're not able to continue to increase the NIH's budget ... I think that's one of our goals, to try to get back to a period where there was a predictable and sustainable increase." 5. Introducing the Bench to Bedside Podcast

The AAMC <u>posted</u> the first feature in its new Bench to Bedside Podcast series, which presents stories of patients who have benefited from medical research. The Feb. 28 post focuses on twins, Alexis and Noah Beery, and how genome sequencing helped diagnose them with a rare form of dystonia. The recurring

podcast is part of the AAMC Research Means Hope campaign, which promotes the value of medical research and advocates for sustained, predictable federal funding for the National Institutes of Health.

6. NDD Letter to Congress, the Administration, and Media

NDD United sent a <u>letter</u> signed by 2,000 national state, and local organizations to Congress, the President, and over 500 members of the media. The letter requests adequate funding for nondefense discretionary (NDD) programs, stating that "Congress and the President must work together to protect NDD programs from further cuts and end sequestration. Such sequestration relief must be equally balanced between nondefense and defense programs, as strong investments in both NDD and defense are necessary to keep our country competitive, safe, and secure."

7. Letter to President Trump on the Prevention and Public Health Fund

On Mar. 3, through a community letter organized by the Trust for America's Health (TFAH), over 500 organizations <u>sent</u> a letter to the President opposing the repeal of the Prevention and Public Health Fund (PPHF). The letter notes that because the PPHF currently supports more than 12 percent of the Centers for Disease Control and Prevention's (CDC) budget, eliminations of the PPHF would not only affect the CDC budget, but also would present a challenge "to the LHHS bill as a whole, leaving a nearly \$1 billion budget hole which would be impossible to fill under current discretionary spending caps."
