Chairwoman Lowey Discusses Supplemental Funding on NPR

House Appropriations Committee Chairwoman Nita Lowey (D-N.Y.) <u>was interviewed</u> on NPR's *Weekend Edition* on April 5, where she discussed Congress's ongoing work on providing supplemental funding to combat COVID-19. Chairwoman Lowey discussed the March 27 passage of the Coronavirus Aid, Relief, and Economic Security Act (CARES) Act, and looked to additional future funding in a fourth supplemental spending bill.

FY 2021 Labor-HHS Outside Witness Testimony

The Senate Appropriations Labor-HHS Subcommittee has posted instructions for submitting outside witness testimony for FY 2021. <u>According to the instructions</u>, testimony should be no longer than four pages and sent to the Subcommittee no later than close of business May 22.

NIH ICs Post Additional Funding Opportunities for COVID-19 Research

The NIH's National Institute on Aging (NIA) and National Institute of Mental Health issued a <u>Notice of Special Interest</u> (NOSI) on the Availability of Administrative Supplements and Revision Supplements on Coronavirus Disease 2019 (COVID-19). Applications will be accepted on a rolling basis through May 1.

NCI COVID-19 Guidance for Researchers

The National Cancer Institute (NCI) <u>published</u> resources and guidance for cancer researchers related to COVID-19. The webpage includes information on extramural funding, clinical trials, and intramural research, as well as links to related resources.

AACR Letter Recommending Support for Patients and Researchers During Pandemic

Last week the American Association for Cancer Research (AACR) sent a <u>letter to</u> <u>Congress</u> recommending several actions to alleviate the current COVID-19 public health emergency while protecting patients with cancer and sustaining investment in vital medical research. The AACR also sent a similar <u>letter</u> to President Trump, Vice President Pence, and members of the White House Coronavirus Task Force.

302(b) Sign On Letter

The Coalition for Health Funding, Committee for Education Funding, Coalition on Human Needs, and Campaign to Invest in America's Workforce, are circulating their annual 302(b) sign-on letter, a joint effort with the open for organizations to join. This sign on letter has been updated to reflect recent congressional action on the COVID emergency appropriations.

Requests for Public Comment

OSTP Requests Information on Public Access to Publications, Data – April 6

The White House Office of Science and Technology Policy (OSTP) is requesting information on public access to peer-reviewed scholarly publications, data, and code resulting from federally funded research. This request is part of the OSTP and the National Science and Technology Council's efforts to facilitate implementation and compliance with the 2013 memorandum on Increasing Access to the Results of Federally Funded Scientific Research and to address recommended actions made by the Government Accountability Office in a 2019 report. Comments must be submitted by the new date of April 6.

NIDDK Seeks Feedback on Strategic Plan – May 18

NIH's National Institute of Diabetes and Digestive and Kidney Diseases (NIDDK) issued a March 16 <u>request for information</u> on the institute's five-year strategic plan. According to the RFI, "The goal of the process is to develop a broad vision for accelerating research into the causes, prevention, and treatment of diseases and conditions within the Institute's mission," and focuses on five broad themes for community input. <u>Comments are due</u> by May 18.

NINDS Seeks Feedback on Strategic Planning Process

The National Institute of Neurological Disorders and Stroke (NINDS) is embarking on an institute-wide strategic planning process, and published a <u>July 2019 request for information</u> on the process. The goal of the process is to tune its practices and policies to its vision and mission, in order to better serve and anticipate the needs of the research and patient communities and the public. The mission of NINDS is to seek fundamental knowledge about the brain and nervous system and to use that knowledge to reduce the burden of neurological disease. Those interested in submitting comments for consideration as NINDS establishes a new strategic plan may still do so through this form.
