President Signs \$484 Billion Interim COVID-19 Relief Package

President Donald Trump signed into law the Paycheck Protection Program and Health Care Enhancement Act (P.L. 116-139), a \$484 billion interim supplemental spending package, on April 24 to provide relief and response to the COVID-19 pandemic. The signing follows passage by unanimous consent in the Senate on April 21 and House passage in a 355-8 vote on April 23. The legislation includes \$25 billion for costs related to COVID-19 testing, which contains \$1.8 billion for NIH, distributed as \$306 million for the National Cancer Institute, \$500 million for the National Institute of Biomedical Imaging and Bioengineering, and \$1 billion to the Office of the Director, which includes support for public-private partnerships.

NIH Director's Blog: The Challenge of Tracking COVID-19's Spread

On April 23, NIH Director Francis Collins, MD, PhD, <u>posted on his blog</u> about "ways to use testing technologies to our best advantage" to defeat COVID-19, distinguishing between the usefulness of identifying individuals without symptoms and individuals who had already been infected but only had mild symptoms. Dr. Collins discussed research out of China on testing of moderately ill patients throughout their hospital stay to study the viral load and infectiousness of the progressing disease.

NIH FOA: Long-Term Effects of Disasters on Health Care Systems and Disparity

Four NIH Institutes and Centers (ICs) have jointly issued a <u>funding opportunity</u> <u>announcement</u> to research the long term effects of disasters on health disparity populations and the health care systems that serve them. The research applies to presidentially declared emergencies or other statutory definitions of emergency and may

include COVID-19, Zika, influenza, power outages, food-disruptions and such. The participating ICs include NIMHD, NIA, NIDA, and NCI. Letters of intent are due September 4, 2020.

AAMCNews: Labs Put Research on Ice

<u>AAMCNews</u> reported on April 21 on the unprecedented questions basic science researchers and lab directors have faced as stay-at-home orders related to COVID-19 shuttered university labs. Researchers and administrators from across the country discuss their concerns and address questions such as: What research is allowed to continue and what has stopped? What science is likely to be lost? Who will pay to resume experiments?

FY 2021 Labor-HHS Outside Witness Testimony

The Senate Appropriations Labor-HHS Subcommittee has posted instructions for submitting outside witness testimony for FY 2021. <u>According to the instructions</u>, testimony should be no longer than four pages and sent to the Subcommittee no later than close of business May 22.

OBSSR Seeks Feedback on Scientific Priorities – April 30

The NIH Office of Behavioral and Social Sciences Research (OBSSR) is seeking stakeholder feedback on research directions to support OBSSR's strategic plan. Specifically, OBSSR seeks feedback on "OBSSR would like input on the most important or cutting-edge, trans-disease research directions that would accelerate progress" in the following areas: synergy in basic and applied BSSR; BSSR resources, methods, and measures; and adoption of effective BSSR in practice. Responses are due by April 30 via submission via obssr.ideascale.com.

NIDDK Seeks Feedback on Strategic Plan – July 31

NIH's National Institute of Diabetes and Digestive and Kidney Diseases (NIDDK) issued a March 16 <u>request for information</u> on the institute's five-year strategic plan. According to the RFI, "The goal of the process is to develop a broad vision for accelerating research into the causes, prevention, and treatment of diseases and conditions within the Institute's mission," and focuses on five broad themes for community input. <u>Comments are due</u> by July 31.

NINDS Seeks Feedback on Strategic Planning Process

The National Institute of Neurological Disorders and Stroke (NINDS) is embarking on an institute-wide strategic planning process, and published a <u>July 2019 request for information</u> on the process. The goal of the process is to tune its practices and policies to its vision and mission, in order to better serve and anticipate the needs of the research and patient communities and the public. The mission of NINDS is to seek fundamental knowledge about the brain and nervous system and to use that knowledge to reduce the burden of neurological disease. Those interested in submitting comments for consideration as NINDS establishes a new strategic plan may still do so <u>through this form</u>.

The American Association for Cancer Research (AACR) will present segments of their previously terminated Annual Meeting in two AACR Virtual Annual Meetings, the first of which is taking place April 27-28. More than 30,000 have already registered, underscoring the interest in and enthusiasm for broadly sharing important and lifesaving research.
