House Labor-HHS Subcommittee Hearing on COVID-19 Response – May 6

The House Labor-HHS appropriations subcommittee <u>will hold a hearing</u> on Wednesday, May 6 at 10:00am titled, "COVID-19 Response." Witnesses include Tom Frieden, MD, President and CEO of Resolve to Save Lives, and former Director of the Centers for Disease Control and Prevention, and Caitlin Rivers, PhD, Senior Scholar at the Johns Hopkins Center for Health Security, Assistant Professor in the Department of Environmental Health and Engineering at the Johns Hopkins Bloomberg School of Public Health. The hearing will be webcast.

Senate HELP Hearing on COVID-19 Testing – May 7

The Senate Health, Education, Labor, and Pensions Committee <u>will hold a hearing</u> on Thursday, May 7, at 10:00am titled, "Shark Tank: New Tests for COVID-19." NIH Director Francis Collins, MD, PhD, and Acting Director of the Biomedical Advanced Research and Development Authority (BARDA) Gary Disbrow, PhD, will testify.

Ad Hoc Group Letter Urges Support for NIH in COVID-19 Supplementals

The Ad Hoc Group for Medical Research sent <u>an April 27 letter</u> to congressional leaders urging \$31 billion in additional supplemental funding for NIH in future comprehensive COVID-19 relief bills. This recommendation includes the NIH's proportion of the \$26 billion request proposed in <u>an April 29 letter</u> from members of the House of Representatives, as well as additional funding for more COVID-19 research, ramping up research activities that have stalled during the pandemic, and long-term investments in the workforce and physical laboratory infrastructure. The letter also encourages Congress to include statutory language in the next package to exempt key HHS programs from the regular appropriations discretionary spending caps for fiscal year 2021.

"Beyond the White Coat" Podcast Interviews NIH Director on COVID-19 Efforts

Skorton, MD, AAMC president and CEO, talks with Francis Collins, MD, PhD, director of the NIH, about NIH's newly announced RADx (Rapid Acceleration of Diagnostics) initiative, the importance of public-private partnerships, the important of basic research, and more.

ASBMB Webinar: COVID-19 Interruptions to NIH Research

The American Society for Biochemistry and Molecular Biology (ASBMB) hosted <u>an April</u> <u>20 webinar</u> with NIH representatives Michael Lauer, MD, deputy director for extramural research and director of the Office of Extramural Research, and Jodi Black, PhD, deputy director of the Office of Extramural Research at the NIH on the pandemic's impact to NIH-funded research. Key takeaways include: NIH is a resource that scientists should utilize during the crisis; the recently passed CARES Act includes research-specific benefits; and more work is needed to ensure scientists and their labs are better prepared for future pandemics.

NIH Announces Study on COVID-19 Incidence in Children

<u>A May 4 NIH news release</u> announced the start of the Human Epidemiology and Response to SARS-CoV-2 (HEROS) study, sponsored by the National Institutes of Allergy and Infectious Diseases (NIAID). The six-month study will enroll members from 2,000 families across the U.S. with the goals of determining a rate of SARS-CoV-2 infection in children and their families and the percentage of infected children who develop symptoms, and investigating differences between healthy children and those with asthma or other allergic conditions.

NOSI and Emergency Awards for COVID-19 Research

The week of April 27, three NIH institutes released notices on new funding opportunities for COVID-19 research. <u>National Institute of Neurological Disorders and Stroke (NINDS)</u> issued a Notice of Special Interest (NOSI) "to rapidly improve our understanding of the neurological consequences of infection of SARS-CoV-2 and of COVID-19." The National Institute of Allergy and Infectious Diseases (NIAID) released notices on emergency awards for <u>R21 Exploratory/Developmental Research Grants</u> and an <u>R01 Research</u> <u>Project Grants</u>. The <u>National Cancer Institute (NCI)</u> issued a Notice of Information regarding the ability of "funded grantees and cooperative agreement awardees to engage in limited COVID-19 related research using part of their existing NCI-funded resources."

FY 2021 Labor-HHS Outside Witness Testimony

The Senate Appropriations Labor-HHS Subcommittee has posted instructions for submitting outside witness testimony for FY 2021. <u>According to the instructions</u>, testimony should be no longer than four pages and sent to the Subcommittee no later than close of business May 22.

ASBMB Sign-On Letter, Op-Ed in Support of Peer-Reviewed Science

The American Society for Biochemistry and Molecular Biology (ASBMB) is <u>circulating a</u> <u>sign-on letter</u> to President Trump expressing concern over the administration's recent revocation of a peer-reviewed NIH research grant for studies of coronaviruses by EcoHealth Alliance. ASBMB Public Affairs Director Ben Corb also published an April 30 <u>op-ed in CNN</u> noting concern over the politicization of peer-reviewed science. NCCIH Seeks Feedback on Strategic Plan – June 30

NIH's National Center for Complementary and Integrative Health (NCCIH) issued an April 27 request for information on the Center's five-year strategic plan. According to the RFI, "The NCCIH is developing a new strategic plan to guide the Center's research efforts and priority setting for 2021 through 2026. Seeking input into the strategic planning process is critical for identification and consideration of research areas and topics to be included in the new plan. NCCIH is requesting input in any or all of 9 topic areas." Comments are due by June 30.

NIDDK Seeks Feedback on Strategic Plan – July 31

NIH's National Institute of Diabetes and Digestive and Kidney Diseases (NIDDK) issued a March 16 <u>request for information</u> on the institute's five-year strategic plan. According to the RFI, "The goal of the process is to develop a broad vision for accelerating research into the causes, prevention, and treatment of diseases and conditions within the Institute's mission," and focuses on five broad themes for community input. <u>Comments are due</u> by July 31.

NINDS Seeks Feedback on Strategic Planning Process

The National Institute of Neurological Disorders and Stroke (NINDS) is embarking on an institute-wide strategic planning process, and published a <u>July 2019 request for</u> <u>information</u> on the process. The goal of the process is to tune its practices and policies to its vision and mission, in order to better serve and anticipate the needs of the research and patient communities and the public. The mission of NINDS is to seek fundamental knowledge about the brain and nervous system and to use that knowledge to reduce the burden of neurological disease. Those interested in submitting comments for consideration as NINDS establishes a new strategic plan may still do so through this form.
