#### Ad Hoc Group Weekly Round Up – June 17, 2019

#### 1. House Begins Floor Consideration of FY 2020 Labor-HHS Bill

The House June 12 began debate on amendments to the FY 2020 Labor-HHS spending bill as a part of the four-bill "minibus" spending package (H.R. 2740), including Defense, Energy and Water, and State and Foreign Operations spending bills. Of the nearly 70 Labor-HHS <u>amendments</u> considered, the House approved 64, including Rep. Pocan (D-Wis.)'s <u>amendment</u> to prevent implementation of HHS's June 5 policy on extramural fetal tissue research. Not approved was an amendment to reduce spending for the entire Labor-HHS spending bill by 14 percent, offered by Rep. Banks (R-Ind.).

Consideration of the entire four-bill spending package with amendments is expected to continue the week of June 17 before the House votes on final passage. The Senate has yet to establish a timeline for consideration of its FY 2020 Labor-HHS spending bill.

#### 2. Congress, White House Continue Budget Negotiations

Senate Republicans June 12 met with members of the Trump administration to continue discussions on budget caps for FY 2020 and the debt ceiling. As reported in <u>CQ</u> (subscription required), the Senate "will likely 'deem' a topline spending level for fiscal 2020 appropriations bills after lawmakers return from the July Fourth recess, unless a spending caps deal is struck before then." Senate Appropriations Committee Chair Richard Shelby (R-Ala.) noted that Congress will continue to push for a two-year budget caps deal, though is unsure of the administration's preference for a one- or two-year deal.

#### 3. NIH ACD Meeting Presents Updates on Sexual Harassment, Foreign Influence

The NIH Advisory Committee to the Director (ACD) June 13-14 held a public <u>meeting</u> covering a range of topics. In particular, the ACD Changing the Culture to End Sexual Harassment working group <u>presented</u> an interim report including four recommendations, future topics to discuss, and a plan to produce a final report by the December 2019 ACD meeting. NIH Principal Deputy Director Michael Lauer, MD, <u>presented</u> on behalf of the working group on Foreign Influences on Research Integrity, which shared recommendations at the December 2018 meeting. Dr. Lauer emphasized that international collaborations "are acceptable and encouraged, [and] we urge researchers to err on the side of transparency."

#### 4. NIH Director: Time to End the Manel Tradition

NIH Director Francis Collins, MD, PhD, June 12 <u>announced</u> that he will no longer participate in all-male speaking panels, or "manels," often found at scientific conferences. Citing NIH's commitment to create an "inclusive and diverse workforce, Dr. Collins noted, "It is not enough to

give lip service to equality; leaders must demonstrate their commitment through their actions." Dr. Collins clarified that if "attention to inclusiveness is not evident in the agenda, I will decline to take part" in speaking engagement invitations and encouraged other scientific leaders to do the same.

# 5. Open Mike: How to Notify NIH about a Concern on Sexual Harassment

NIH Deputy Director for Extramural Research Michael Lauer, MD, June 14 <u>posted</u> on his *Open Mike* blog the announcement of a new website "that allows for anybody in the biomedical research community to share information related to a potential case of sexual harassment directly and, if desired, anonymously, to NIH." Dr. Lauer notes that NIH can and will follow up on all concerns related to NIH-funded research submitted through the site and encourages individuals to also report allegations of sexual harassment or assault to appropriate authorities, including institution equal employment opportunity or human resource offices.

# 6. New NIH Resource on Legacy of Henrietta Lacks

The NIH Office of Science Policy June 13 shared a <u>blog post</u> about a new collaboration with the NIH Library to assemble a <u>resource</u> on the legacy of Henrietta Lacks in biomedical research. Cells from Ms. Lacks' cervical cancer were extracted 65 years ago, and the cells have contributed to important research findings and therapeutics all over the world, including the "development of the polio vaccine, the advent of recombinant DNA technology, [and] nanotechnology treatment for cancer."

## 7. NCI Cancer Currents: The Childhood Cancer Data Initiative

The NIH's National Cancer Institute (NCI) discussed its plans to develop a Childhood Cancer Data Initiative (CCDI), which would aim to "establish more efficient ways to share and use childhood cancer data to help identify novel therapeutic targets and approaches, underpin new drug development, and enable new research pursuits to better understand the biology of childhood cancers," in a Cancer Currents <u>blog post</u>. The NCI is hosting a <u>symposium</u> to shape the scientific direction of the CCDI July 29-31 in Washington DC and is soliciting abstracts for posters until June 30.
