### **The Nobel Prize @NobelPrize**

"BREAKING NEWS: The 2019 [#NobelPrize](#) in Physiology or Medicine has been awarded jointly to William G. Kaelin Jr, Sir Peter J. Ratcliffe and Gregg L. Semenza 'for their discoveries of how cells sense and adapt to oxygen availability.'"

#### **1. Nobel Prize Awarded in Physiology or Medicine**

The 2019 Nobel Prize in Physiology or Medicine announced October 7 is awarded to William G. Kaelin Jr, MD, Sir Peter J. Ratcliffe, MD, and Gregg L. Semenza, MD, PhD, for their work in understanding how cells sense and adapt to low oxygen levels. According to [an NIH press release](#), "Dr. Kaelin has received continuous funding since 1990, totaling more than \$30 million from NIH's National Cancer Institute. Dr. Semenza has received funding from NIH since 1988, totaling more than \$20.3 million, primarily from NIH's National Heart, Lung, and Blood Institute and National Institute of Diabetes and Digestive and Kidney Diseases."

#### **2. NIH Announces \$945 Million in Funding Through HEAL Initiative**

The NIH [September 26 announced](#) \$945 million awarded in FY 2019 to fund "grants, contracts and cooperative agreements across 41 states through the Helping to End Addiction Long-term Initiative (HEAL)." NIH Director Francis Collins, MD, PhD, noted that this multi-institute initiative utilizes expertise from many disciplines to address substance use disorder by "accelerat[ing] development of effective non-opioid therapies for pain and provid[ing] more flexible and effective options for treating addiction to opioids."

#### **3. Open Mike: Seeking Comments on Using Fast Healthcare Interoperability Resources**

The NIH is [soliciting public input](#) on "how the Health Level Seven International (HL7®) Fast Healthcare Interoperability Resources (FHIR®) standard could be used to capture, integrate, and exchange clinical data for research purposes and to enhance capabilities to share research data." NIH Deputy Director for Extramural Research Mike Lauer, MD, explains in an [Open Mike blog post](#) that the NIH wants to "hear more from the community on ways to strengthen approaches that find, share, and access high-quality patient data, while also making it more interoperable and reusable." Comments must be [submitted by November 23](#).

#### **4. Sen. Grassley Calls for Immediate Action on HHS OIG Reports**

Senator Chuck Grassley (R-Iowa) [September 27 issued a news release](#) calling for immediate action on a [September 25 report](#) from the Department of Health and Human Services (HHS) Office of Inspector General (OIG). The OIG report titled, "NIH Has Made Strides in Reviewing Financial Conflicts of Interest in Extramural Research, But Could Do More," recommends that NIH perform periodic reviews of financial conflicts of interest and use information on foreign affiliations to inform any future changes to the financial-conflict review process. Sen. Grassley in

particular called for improvements of NIH oversight of conflicts of interest and foreign influence in NIH grant review.
