Little Progress Made On FY 2020 Appropriations as CR Deadline Nears

The Senate the week of October 21 began consideration of a spending package of four bills that passed unanimously out of the Senate Appropriations Committee, and is expected to complete debate on the package this week. Senate Majority Leader Mitch McConnell (R-Ky.) announced that after the first four-bill package, the Senate would again attempt consideration of another package, including the Labor-HHS spending bill, that failed to gather enough votes to advance in September.

The federal government is currently under a continuing resolution (CR) that expires on November 21, and Senate Appropriations Committee Chair Richard Shelby (R-Ala.) October 23 told reporters (CQ, subscription required) that a second CR extending into February or March is a likely possibility. The Ad Hoc Group for Medical Research October 24 sent a letter with over 300 signatories to House and Senate Appropriations leadership stating, "To enable passage of a bipartisan spending package that maximizes investment in NIH, we strongly urge you to provide a meaningful increase in the allocation for Labor-HHS-Education appropriations and complete the spending bill as soon as possible."

Time: NIH Director Lays Out Vision of the Future of Medical Science

Time Magazine featured an October 24 commentary by NIH Director Francis Collins, MD, PhD, laying out his vision for the future of medical science. Dr. Collins writes, "Our world has never witnessed a time of greater promise for improving human health. Many of today's health advances have stemmed from a long arc of discovery that begins with strong, steady support for basic science." He highlights that despite much progress in improving human health, "much more remains to be done," including through the use of gene editing, cancer immunotherapy, mapping the human brain, and improving the uses of personalized medicine. Dr. Collins also emphasizes the importance of applying such breakthroughs ethically and equitably.

NIH Launches Collaboration on Gene-Based Cures for Sickle Cell and HIV

The NIH October 23 announced a new collaboration with the Bill & Melinda Gates Foundation with the goal of developing gene therapy cures for sickle cell disease (SCD) and HIV, with the intent of providing the cures around the world in the next seven to 10 years. The NIH and Gates Foundation will invest \$100 each towards this goal. NIH Director Francis S. Collins, MD, PhD, noted, "This unprecedented collaboration focuses from the get-go on access, scalability and affordability of advanced gene-based strategies for sickle cell disease and HIV to make sure everybody, everywhere has the opportunity to be cured, not just those in high-income countries."

NIH Researchers Author Commentary on Path to Ending HIV

National Institute of Allergy and Infectious Disease Director Anthony Fauci, MD, co-authored an October 24 *Clinical Infectious Disease* commentary on ending the HIV pandemic. According to the NIH press release, despite significant advancements in HIV treatment and prevention with antiretroviral therapy (ART) and pre-exposure prophylaxis (PrEP), gaps still remain in implementing these diagnostic and treatment tools. The statement notes, "Researchers are pursuing multiple approaches to achieve durable control of HIV without daily ART, including pursuing a cure that would eradicate HIV from the body or keep it at very low levels, and developing long-acting ART and broadly neutralizing antibodies (bNAbs) that could be dosed once every few months or less often," to improve use of these clinical tools in diverse patient populations.
