Congressional and NIH News

COVID-19 Relief Negotiations Slow, Possibility of Lame-Duck Spending Deal

House Speaker Nancy Pelosi (D-Calif.) sent an [October 29 letter](#) to Treasury Secretary Steven Mnuchin outlining the issue areas for which she is awaiting an administration response as part of ongoing negotiations on a new COVID-19 relief package. The months-long negotiations have yielded little progress, forcing Congressional leaders to consider the possibility of passing a COVID-19 relief bill in the lame-duck session. As reported [October 28 in Roll Call](#), Congressional leaders have attempted to push forward COVID-19 relief separately from the annual appropriations bills, but “the possibility of post-election tumult and the stopgap spending law expiring on Dec. 11, could incentivize lawmakers to add coronavirus-related aid to the [FY 2021] appropriations bills.”

Rep. Kaptur Releases Comprehensive Vision for House Appropriations

House Appropriations Energy & Water Subcommittee Chairwoman Marcy Kaptur (D-Ohio) released a two-page vision of a path forward for the full committee, unofficially making her pitch to replace retiring Committee Chairwoman Nita Lowey (D-N.Y.) in the 117th Congress. As reported [October 26 in Roll Call](#), Rep. Kaptur's plan includes restoring earmarks for local projects in spending bills and removing the Hyde amendment from the Labor-HHS spending bill. Rep. Kaptur also plans to promote subcommittees working together for programs that span appropriations jurisdictions.

NIH Releases Final Policy for Data Management and Sharing

The NIH on October 29 released the [Final NIH Policy for Data Management and Sharing](#) which requires NIH funded researchers to prospectively submit a plan outlining how scientific data will be managed and shared. This will go into effect on January 25, 2023 and replace the 2003 NIH Data Sharing Policy. [In a statement](#), NIH Director Francis Collins, MD, PhD, noted that the policy “establishes the baseline expectation that data sharing is a fundamental component of the research process, which is in line with NIH’s longstanding commitment to making the research it funds available to the public.” NIH Associate Director for Science Policy Carrie Wolinetz, PhD, authored an [Under the Poliscope blog post](#) on the policy, noting, “Responsible data management and sharing is

good for science; it maximizes availability of data to the best and brightest minds, underlies reproducibility, honors the participation of human participants by ensuring their data is both protected and fully utilized, and provides an element of transparency to ensure public trust and accountability.”

NIGMS Deputy Director Judith Greenberg, PhD, to Retire

National Institute of General Medical Sciences (NIGMS) Deputy Director Dr. Judith Greenberg will retire at the end of October after 45 years of service according to an [October 23 Feedback Loop blog post](#). NIGMS Director Jon Lorsch, PhD, praised Dr. Greenberg’s service to the NIH and the academic community. Lorsch separately announced Dorit Zuk, PhD, as acting deputy director in a separate [October 28 Feedback Loop blog post](#).

Apply for HIV Clinical Training Opportunities – January 19, 2021

[The HIV Medicine Association \(HIVMA\)](#) and the [Infectious Diseases Society of America \(IDSA\) Foundation](#) are accepting applications for the [2021 HIV Clinical Fellowship Program](#). For the first time, the program is supporting one year of HIV clinical training for full or half-time effort awards to allow greater flexibility for physicians to train in community-based settings. The award supports a stipend of \$33,000 for half-time training or \$65,000 for full-time, plus funding to cover fringe benefits. Physicians whose communities are underrepresented in medicine or who interested in working in the Southeastern United States are strongly encouraged to apply.
