### **1. Ad Hoc Group Sends Letter to Congressional Leadership**

On Nov. 2, 216 patient, medical, scientific, academic, and research organizations of the Ad Hoc Group [sent a letter](#) to congressional leadership, urging the enactment of a bicameral, bipartisan budget agreement that raises the spending caps and enables a \$36.1 billion investment in NIH in FY 2018, as approved by the Senate Appropriations Committee. Signatories of the letter thank congressional leaders for maintaining the NIH as a key national priority but caution that “without relief from sequestration, final funding for critical federal agencies like the NIH could face significant hurdles.” The letter adds that while the United States is known for its outstanding medical research capacity, “discretionary spending caps imposed by sequestration will jeopardize our competitive edge in an increasingly innovation-based global marketplace. To maintain our leadership, we must reaffirm this commitment by providing the biomedical research enterprise the support needed to maintain our competitive edge.”

### **2. NIH Director Comments on Funding at University of Michigan Talk**

On Nov. 2 at the University of Michigan, NIH Director Francis Collins, MD, PhD, spoke about NIH funding in the current political climate. According to [press reports](#), Dr. Collins stated, "While everything right now seems kind of polarized, this is one place where I think we've managed to escape that. This is not just a cost, but an investment - an investment in people's lives." Dr. Collins emphasized that biomedical research funding is a bipartisan priority among lawmakers.

### **3. NIH Funding and Partnerships Mentioned in Opioid Commission Report**

On Nov. 2, the President's Commission on Combating Drug Addiction and the Opioid Crisis submitted its [final report](#), including recommendations regarding biomedical research. The report highlighted the partnership with the NIH and pharmaceutical companies to develop non-addictive painkillers and new treatments and instructs Congress and the Federal Government to “provide additional resources to the National Institute on Drug Abuse, the National Institute of Mental Health, and National Institute on Alcohol Abuse and Alcoholism.”

On Nov. 10, The Society for Neuroscience (SfN) will host a [2017 Neurobiology of Disease Workshop](#), “Gene Therapy to Address Unmet Needs in Neurology.” This workshop will feature Florian Eichler, MD, Xandra O. Breakefield, PhD, and [others](#) to discuss the breadth of current and emerging gene therapy approaches to treat neurologic disorders such as Alzheimer’s disease, ALS, or muscular dystrophy. This workshop embraces the breadth of "gene therapy" including viral vectors, oligonucleotides, and cell therapies used in promising preclinical studies and clinical trials for a variety of neurologic disorders long thought to be incurable. These new methods involve DNA engineering, gene replacement using virus vectors and the patient's own genetically modified cells, oligonucleotides that can "revive" beneficial gene functions or suppress toxic ones, and viruses and cells armed to tackle brain tumors.
