1. Joint Select Committee on Budget and Appropriations Continues Markup

The Joint Select Committee on Budget and Appropriations Process Reform Nov. 27 will continue to mark up its proposed legislative language, which began during a <u>Nov. 15 markup</u>. The meeting will take place in 1334 Longworth House Office Building beginning at 2pm.

2. Update on Cancer Moonshot – Moving from Planning to Research

Co-Chair of the Cancer Moonshot Blue Ribbon Panel and NCI Acting Deputy Director Dinah Singer, PhD, Nov. 19 <u>published</u> a Cancer Moonshot progress report in the Cancer Currents Blog. Dr. Singer shared updates on the science being funded by the Cancer Moonshot, including research teams with various goals: one focused on immunotherapy in adults and another in children; identifying immune targets and treatments specific to pediatric cancers; implementation science to make progress in cancer prevention and early detection; and a focus on basic research.

3. NIH Statement on World COPD Day 2018

The NIH Nov. 20 <u>issued a statement</u> in conjunction with World COPD Day 2018, renewing the agency's "long-standing commitment to reducing the burden of chronic obstructive pulmonary disease (<u>COPD</u>), a serious and debilitating lung disease." NIH, through NHBLI, joins in multiple partnerships to find a COPD cure, including the COPD National Action Plan, the COPD Clinical Research Network, and the COPD Learn More Breathe Better program.

4. STAT: Chinese Researcher Claims Birth of First Gene-Edited Babies

STAT and other media outlets Nov. 25 <u>reported claims</u> of Chinese scientist He Jiankui, PhD, that he used the gene-editing tool CRISPR to edit human embryos, resulting in the birth of twin girls. Dr. Jiankui used CRISPR to target a cell membrane protein that allows HIV to enter cells in an effort to prevent future HIV infection. Dr. Jiankui's claims have not gone through peer review for publication in a scientific journal. In response to the reports, University of California Berkeley's Li Ka Shing Chancellor's Chair in Biomedical and Health Sciences and Professor of Biochemistry, Biophysics and Structural Biology and co-inventor of CRISPR-Cas 9 gene editing Jennifer Doudna, PhD, <u>released a statement</u> urging the public to put the likely "sensationalized headlines" in perspective. She continues, "It is essential that this report not cast an untoward shadow on the many important ongoing and planned clinical efforts to use CRISPR technology to treat and cure existing genetic, infectious, and common disease in adults and in children."

5. STAT: Launch of an Ebola Clinical Trial Draws Near

STAT <u>reported Nov. 12</u> on an upcoming clinical trial for Ebola patients in the Democratic Republic of the Congo (DRC). The trial will compare four treatments without placebo, including mAB 114, a monoclonal antibody regimen being developed by the NIH and DRC's National Institute of Biomedical Research. This trial has unique challenges due to local violence, its taking place in the midst of an outbreak, and the current lack of protocol standardization.

6. STAT: To Catch Misconduct, Journals are Hiring Research Integrity Czars

Also in *STAT* <u>Nov. 21</u>, Ivan Oransky and Adam Marcus report on scientific publishers' hiring of scientific integrity officers, or "integrity czars" to investigate potential research misconduct before research is published. Hindawi Head of Research Integrity Matthew Hodgkinson comments, "We've always been seeing issues like plagiarism, like authorship disputes, like data fabrication. But there was a lack of awareness of the scale ... [which] reflected the realization that we need to be catching these issues as a core focus."

American Heart Association Seeks Government Relations Manager on Appropriations and Regulatory Affairs Manager

This <u>Government Relations Manager</u> represents the American Heart Association before Congress and the Executive Branch agencies on legislative and regulatory issues related to biomedical research heart disease and stroke prevention programs. Responsibilities include: developing and executing appropriations requests before the House and Senate Labor Health and Human Services, Education and Related Agencies Appropriation Subcommittees for the National Institutes of Health (NIH) and for heart disease and stroke prevention programs administered by the Centers for Disease Control and Prevention (CDC). This position is also responsible for developing knowledge and expertise (and when applicable, advocacy positions) related to all issues relevant to the research environment. The Government Relations Manager will devise strategies and tactics to achieve specific policy objectives in collaboration with AHA media, grassroots and policy staff; serve on coalitions and other external working groups or organizations focused on research and prevention issues; build relationships and maintain communications with Members of Congress, Executive agency officials, and their staff. This position will also manage two external coalitions focused on research and prevention funding for heart disease and stroke.

Under the direction of the Vice President of Federal Advocacy, the <u>Regulatory Affairs Manager</u> would be responsible for monitoring, analyzing, and drafting responses to a prescribed set of federal regulatory and reimbursement-related issues that impact the association's public policy agenda. The primary focus of the AHA's regulatory work is with the Department of Health and Human Services and its key agencies: Centers for Medicare and Medicaid Services, Food and Drug Administration, and Health Resources and Services Administration. Major topics would include rules that impact ACA markets and patient protections, Medicare coverage determinations and Medicare payment rules, and FDA initiatives focused on drug/device development and safety. As part of your work, you would also identify opportunities for high level volunteers and staff to serve as representatives of the Association on appropriate federal regulatory and oversight bodies, including advisory panels and councils. Other duties may include providing limited lobbying support on proposals related to delivery system reform, quality improvement, laboratory developed tests, and other issues.
