# 1. House Energy & Commerce Committee 21st Century Cures Hearing

On Nov. 21, the House Energy & Commerce Committee <u>announced</u> that the Health subcommittee would hold a <u>hearing</u> entitled, "Implementing the 21st Century Cures Act: An Update from FDA and NIH." According to a committee press release, confirmed witnesses include Francis Collins, MD, director of the National Institutes of Health (NIH) and Scott Gottlieb, MD, commissioner of the Food and Drug Administration (FDA). The hearing will take place on Nov. 30 at 10am in 2123 Rayburn House Office Building.

### 2. Senate HELP Committee Hearing on Nominee for HHS Secretary

On Nov. 29, the Senate Health, Education, Labor, and Pensions Committee will hold a <a href="hearing">hearing</a> on the nomination of Alex Azar to serve as Secretary of Health and Human Services (HHS). The hearing will take place at 9:30am in 430 Dirksen Senate Office Building. Mr. Azar worked for Eli Lilly for the past 10 years and has prior experience at HHS during the Bush Administration. If confirmed, Mr. Azar would succeed Secretary Tom Price, MD, who resigned his post in September. Eric Hargan is currently service as the acting secretary for HHS.

#### 3. NIH's Advisory Committee to the Director Scheduled to Meet Dec. 14-15

Through a Federal Register <u>notice</u>, the NIH announced that the Advisory Committee to the Director (ACD) will meet on Dec. 14 from 9am to 5:30pm and Dec. 15 from 9am to 1pm to discuss the NIH Director's report, ACD working group reports, and other business of the committee. The meeting will be held at National Institutes of Health, Building 31, 6th Floor Conference Room 6C, 31 Center Drive, Bethesda, MD. ## 4. Open Mike Blog: Why Project Outcomes Matter in your Interim and Final RPPR

On Nov. 16, NIH's Deputy Director for Extramural Research Mike Lauer, MD, posted a <u>blog</u> <u>entry</u> on the Outcomes section for the Research Performance Progress Report (RPPR). Dr. Lauer asks readers to pay special attention because "any project outcomes submitted on or after Oct. 1, 2017 will be made available to the general public via NIH's Research Portfolio Online Reporting

Tool (<u>RePORTER</u>)." Dr. Lauer wrote up an <u>example</u> of an acceptable report and says that reporting outcomes is "part of our stewardship of the public's investment in research."

## 5. National Orgs Support Outreach Efforts for NIH's All of Us Research Program

On Nov. 16, the NIH <u>announced</u> that the agency is partnering with 14 organizations to get the word out about the <u>All of Us Research Program</u>. According to the press release, the selected organizations will receive a combined \$1 million to help educate their communities about the benefits of participation in this landmark project to accelerate breakthroughs in precision medicine.
