Appropriators Continue Work on FY 2020 Ahead of December 20 Deadline

Appropriations Committee leadership December 4 announced plans for subcommittees to finalize each of the 12 individual FY 2020 spending bills by December 6, including the Labor-HHS spending bill to provide funding for the NIH. Subcommittee leaders were also instructed to submit a list of any remaining "unresolved issues" so that Congressional leaders can determine how to move forward in advance of the December 20 expiration of the current continuing resolution.

House Appropriations Committee Chair Nita Lowey (D-N.Y.) was quoted on December 6 as saying the House could begin voting on final FY 2020 spending bills the week of December 9, however no additional updates on FY 2020 progress have emerged following a weekend of negotiations (<u>CQ</u>, <u>subscription required</u>).

R&D Community Sends Letter to Appropriations Leaders

The Ad Hoc Group for Medical Research joined over 160 other members of the broader research and development (R&D) community in a <u>December 4 letter urging Congressional leadership</u> to work together in finalizing FY 2020 spending bills quickly. The letter, coordinated by the American Association for the Advancement of Science and the American Society for Microbiology, highlights that "uncertainty created by short and long-term [CRs] has severe consequences for science and research" and calls on lawmakers to "work in a bipartisan manner and without delay to complete work on the FY 2020 spending bills so that we can continue to lead the world in science and innovation and improve the health, security and economic strength of our nation."

NIMHD Bill to be Considered at Senate HELP Executive Session

The Senate Health, Education, Labor, and Pensions (HELP) Committee will hold an <u>executive</u> <u>session on December 12</u> at 10:00 am in 430 Dirksen Senate Office Building, including consideration of <u>S. 2927</u>, the <u>NIMHD Research Endowment Revitalization Act of 2019</u>. This bill would "provide that the authority of the Director of NIMHD to make certain research endowments applies with respect to both current and former centers of excellence."

Reps. DeGette, Upton Call for Comments on Cures 2.0

Reps. Diana DeGette Diana DeGette (D-Colo.) and Fred Upton (R-Mich.) Nov. 22 issued a press release and "Call to Action" document on their vision for a second iteration of the 2016 law 21st Century Cures. The lawmakers are seeking community feedback as they develop "Cures 2.0" with focus on the areas of digital health, coverage modernization, harnessing data to empower patients,

and caregiver support. Comments will be accepted through December 16 via email to cures2@mail.house.gov.

NEI Seeks Feedback on Future Research Goals

The National Eye Institute (NEI) December 6 issued a press release seeking public comment on two Requests for Information (RFIs): a strategic planning initiative, the 2020 Vision for the Future, and a new research program, the Anterior Segment Initiative (ASI). Comments related to the NEI Strategic Plan are due January 8, and additional information is available on the 2020 Vision for the Future RFI webpage. Comments related to the ASI are due by January 9, and additional details are available through the RFI notice.
