#### **1. House Labor-H Subcommittee Discusses FY 2019 NIH Budget Request**

On April 11, NIH Director Francis Collins, MD, PhD, accompanied by the directors of five NIH institutes, [testified](#) before the House Labor-HHS-Education (Labor-H) Appropriations Subcommittee regarding the agency's fiscal year (FY) 2019 budget proposal. The subcommittee gave Dr. Collins a warm welcome, though both Subcommittee Chair Tom Cole (R-Okla.) and Ranking Member Rosa DeLauro (D-Conn.) noted disappointment over the funding level proposed for the NIH in the administration's FY 2019 budget request, released prior to enactment of the FY 2018 omnibus that bolstered NIH's budget by \$3 billion. In his testimony, Dr. Collins [highlighted](#) how the NIH has been working to advance medical discovery, and he discussed five key areas to success in science: stable funding support, a vibrant workforce, computational power, new technologies and facilities, and scientific inspiration.

#### **2. NIH Releases FY 2019 Congressional Justification Documents**

#### **3. Sen. Richard Shelby Becomes Chair of the Senate Appropriations Committee**

On April 10, by unanimous consent the Senate adopted [S.Res.456](#) and named Sen. Richard Shelby (R-Ala.) as the new chair of the Appropriations Committee. Chairman Shelby takes over the gavel after the resignation of former Senate Appropriations Chair Thad Cochran, who left the Senate April 1 citing that his health "has become an ongoing challenge." Among other shuffling on the committee, Sen. Cochran's replacement, Sen. Cindy Hyde-Smith (R-Miss.) was appointed to the Senate Appropriations Committee and will serve on the Labor-H subcommittee.

#### **4. House Appropriations Labor-H Subcommittee FY 2019 Members Day Hearing**

The FY 2019 Members Day [hearing](#) for the House Appropriations Labor-H Subcommittee is scheduled for 10am on April 17. The hearing will take place in 2358-C Rayburn House Office

Building. According to the subcommittee's hearing [instructions](#), the deadline for Members of Congress to submit written testimony for the record is also April 17.

### **5. NIH Council of Councils Meeting – May 18**

Through a Federal Register [notice](#), the NIH announced of a meeting of the Council of Councils, scheduled for May 18. Items listed on the agenda include announcements and updates, evaluating the “Broadening Experiences in Scientific Training (BEST)” Awards; NIDA update; an introduction to the use of Non-Human Primates (NHP) in addiction research; NHP models of drug addiction. The meeting will take place at NIH campus, 9000 Rockville Pike, Building 31, C Wing, 6th Floor, Conference Room 10, Bethesda, MD 20892.

### **6. Joint Budget and Appropriations Process Reform Committee Schedules First Public Hearing**

The [Joint Select Committee on Budget and Appropriations Process Reform](#) is scheduled to have its first public meeting on at 10:30am, April 17 in HVC-210, the Capitol. This week's meeting follows the Joint Select Committee [first closed door meeting](#) on March 8.

### **7. NIAID Director Scheduled to Testify Before the House Appropriations Labor-H Subcommittee**

The House Appropriations Labor-H Subcommittee [scheduled](#) a hearing titled, “FY 2019 Budget Health and Human Services Biodefense Activities” for 10am on April 18 in 2358-C Rayburn House Office Building. Among the witnesses scheduled to testify is Anthony Fauci, MD, director of the National Institute of Allergy and Infectious Diseases. According to the committee website, the hearing will be webcast.

### **8. All of Us Research Program Webinar – April 17**

The webinar will feature *All of Us* Director Eric Dishman and Chief Engagement Officer Dara Richardson-Heron, MD, who will speak on several topics, including: the basics of the *All of Us* Research Program, data access and future scientific prospects, connecting patient registries, biobanks, and other health databases with *All of Us*, and ways for organizations to support the program at launch and beyond.
