SRS is continuously open, but medical schools complete three yearly tasks in SRS: the SRS Graduation Certification, the SRS Class Promotions, and the SRS M1 Certification. The SRS Graduation Certification is due the last business day in June, and registrars confirm all students graduating from their institution, as well as their PGY-1 plan information. The SRS Class Promotions are due towards the end of August, and registrars promote each of their class levels to the next year. The M1 Certification is due in mid-October, and registrars are asked to certify their first-
